THE BANKING SERVICES (DESIGNATED FINANCIAL SERVICES)
(PROVISION OF ELECTRONIC RETAIL PAYMENT SERVICES)
ORDER, 2020

In the exercise of the power conferred upon the Supervisor by section 2(1) of the Banking Services Act, the following Order is hereby made:—

- 1. This Order may be cited as the Banking Services (Designated Financial Services) (Provision of Electronic Retail Payment Services) Order, 2020.
 - 2.—(1) In this Order—
 - "electronic retail payment instrument" means the tools and procedures for enabling the transfer of funds from a payer to a payee (whether or not the payer and the payee are the same person), but excludes credit cards;
 - "electronic retail payment service" means the operation and management of activities relating to the use of electronic retail payment instrument, including the rules, standards and procedures governing the relationship, rights, responsibilities and obligations of all participants in those activities.
- 3. The provision of electronic retail payment services is hereby designated as a financial service for the purposes of the Act.
