Extract from the Minutes of the meeting of the Honourable House of Representatives held on Tuesday, June 16, 2020:

#### PUBLIC BUSINESS

The Honourable Robert Montague, Minister of Transport and Mining, having obtained suspension of the Standing Orders, moved:

### THE BAUXITE AND ALUMINA INDUSTRIES (SPECIAL PROVISIONS) ACT

THE BAUXITE AND ALUMINA INDUSTRIES (SPECIAL PROVISIONS) (GENERAL ALUMINA JAMAICA LIMITED) (ASSOCIATED PRODUCER) ORDER, 2020 RESOLUTION

WHEREAS by virtue of section 4(1) of the Bauxite and Alumina Industries (Special Provisions) Act (hereinafter referred to as "the Act") the Minister may, by order, declare to be an associate produce—

(a) any bauxite producer with whom the Government has an agreement in force under which the Government is associated either directly or indirectly with that bauxite

producer in the production of bauxite or alumina in Jamaica or in related enterprises; or

- (b) any person who-
  - (i) is engaged in the winning in Jamaica of bauxite or in the producing in Jamaica of alumina from bauxite won in Jamaica and is in the opinion of the Minister in a special relationship with the Government, or
  - (ii) is engaged in the winning in Jamaica of bauxite or in the producing in Jamaica of alumina from bauxite won in Jamaica or is engaged in other related enterprises or in all those activities and enterprises, and in any case has entered into a special agreement with the Government for the purpose of facilitating the carrying on of those activities or enterprises for rationalising the bauxite industry:

AND WHEREAS on the 10th day of June, 2020, the Minister made the Bauxite and Alumina Industries (Special Provisions) (General Alumina Jamaica Limited) (Associated Producer) Order, 2020 pursuant to section 4(1)(b) of the Act:

AND WHEREAS it is provided by section 4(4) that any order made under section 4(1) of the Act shall be subject to affirmative resolution of the House of Representatives:

NOW THEREFORE, BE IT RESOLVED by this Honourable House of Representatives as follows:—

- 1. This Resolution may be cited as the Bauxite and Alumina Industries (Special Provisions) (General Alumina Jamaica Limited) (Associate Producer) Order, 2020 Resolution.
- 2. The Bauxite and Alumina Industries (Special Provisions) (General Alumina Jamaica Limited) (Associate Producer) Order, 2020, which was laid on the Table of the House on the 16th day of June, 2020, is hereby affirmed.
