THE IRRIGATION ACT

THE COLBECK (IRRIGATION AREA) ORDER, 2020

In exercise of the power conferred upon the Minister by section 3 (1) of the Irrigation Act, and of every other power hereunto enabling, the following Order is hereby made:—

- 1. This Order may be cited as the Colbeck (Irrigation Area) Order, 2020.
- 2. The area described in Part A of the Schedule and delineated on the map set out in Part B of the Schedule is declared to be an irrigation area, for the purposes of the Act.

SCHEDULE

(Paragraph 2)

PART A: Boundary Description of Colbeck Irrigation Area


Commencing at the gridlines intersecting at 736000, 645000; proceed in a westerly direction to north-west of the gridlines intersecting at 734400, 645000. Travel in a northerly direction towards the centre point of the road north-west of the gridlines intersecting at 734400, 645300. Proceed in a north-north westerly direction along the centre of the road to a point north-westerly of the gridlines intersecting at 734800, 645900.

Travel in an easterly direction along the back of the subdivision towards a point north-westerly of the gridlines intersecting at 735200, 645900. Proceed in a northerly direction, approximately forty (40) metres and approximately sixty (60) metres in a westerly direction. Proceed in a northerly direction towards the centre point of the main road west of the gridlines intersecting at 735200, 646200.

Thence, proceed in a south-easterly direction along the main road; and at a point north-westerly of the gridlines intersecting at 736000, 645600, travel in a southerly direction to the intersection of the gridlines of 736000, 645000.
