THE CONCH (EXPORT LEVY) ACT**THE CONCH (EXPORT LEVY) (RATE OF LEVY) ORDER, 2021**

In exercise of the power conferred upon the Minister by section 3(1)(c)(ii) of the Conch (Export Levy) Act, the following Order is hereby made:—

1. This Order may be sited as the Conch (Export Levy) (Rate of Levy) Order, 2021.
2. A levy at a rate of fifty cents in the currency of the United States of America, or the equivalent in Jamaican currency, *per* pound of conch is hereby imposed upon conch exported from Jamaica during the 2021 season.
