**THE EMERGENCY POWERS ACT**

**THE EMERGENCY POWERS REGULATIONS, 2019**

**DETENTION (FABIAN WILLIAMS O/C TALL MAN O/C HOTTIE)  
(STATE OF PUBLIC EMERGENCY FOR THE PARISH OF ST. ANDREW  
SOUTH DIVISION) ORDER, 2019**

In exercise of the power conferred upon the Minister by regulations 33(1) and 38 of the Emergency Powers Regulations, 2019, the following Order is hereby made:—

1. This Order may be cited as the Detention Fabian Williams (o/c Tall Man o/c Hottie) (State of Public Emergency for the Parish of Saint Andrew South Division) Order, 2019.
2. Fabian Williams (o/c Tall Man o/c Hottie) is to be detained from April 6, 2020 until the end of the period of the public emergency which commenced with the Proclamation of the Governor-General published in the Jamaica Gazette Supplement Proclamation, Rules and Regulations on the 7th of July, 2019.

3. For the purposes of paragraph 11 of regulation 38, notice is hereby given as follows:

- (a) Fabian Williams (o/c Tall Man o/c Hottie), has been concerned in acts prejudicial to public safety and public order, more specifically he is suspected of the following:
  - (i) Being involved in the murder of Kevin Kirkland Clarke o/c Rum Ram committed on February 17, 2020; and
  - (ii) Being a top tier member of a criminal organization, namely the Spade Corner Gang, involved in contract killings and extortion.
- (b) Section 13(10) of the Constitution of Jamaica gives you the right to request a review of your case at any time during the period of your detention which is to be reviewed by The Emergency Powers Tribunal and Regulation 38(6) of the Emergency Powers Regulations, 2019, gives you the right to make objection against the Detention Order to The Emergency Powers Review Tribunal.

4. In accordance with paragraph 12 of regulation 38, please be advised of the following:

- (a) The Notice of Objection Form may be accessed from the commanding officer at your place of detention or online at [mns.gov.jm](http://mns.gov.jm).
- (b) A completed Notice of Objection Form may be submitted to the Secretariat of the Emergency Powers Review Tribunal at the Ministry of National Security, Fourth (4th) Floor, NCB Towers, North Tower, 2 Oxford Road, Kingston 5, Saint Andrew or via email to [eprtsas@gmail.com](mailto:eprtsas@gmail.com).
- (c) After the completed Notice of Objection Form has been submitted, you or your representative will be contacted and invited to a hearing where you may present your case to The Emergency Powers Review Tribunal.
