DETENTION (FRANKLYN SUAREZ O/C FRANKLYN SOARES O/C DWIGHT)
(STATE OF PUBLIC EMERGENCY FOR THE PARISH OF ST. JAMES)

ORDER, 2019

In exercise of the power conferred upon the Minister by regulations 33(1) and 38 of the Emergency Powers Regulations, 2019, the following Order is hereby made:—

1. This Order may be cited as the Detention Franklyn Suarez (o/c Franklyn Soares o/c Dwight) (State of Public Emergency for the parish of St. James) Order, 2019.
2. Franklyn Suarez (o/c Franklyn Soares o/c Dwight) is to be detained from October 4, 2019 until the end of the period of the public emergency which commenced with the Proclamation of the Governor-General published in the Jamaica Gazette Supplement Proclamation, Rules and Regulations on the 30th day of April, 2019.

3. For the purposes of paragraph 11 of regulation 38, notice is hereby given as follows:

- (a) Franklyn Suarez (o/c Franklyn Soares o/c Dwight), has been concerned in acts prejudicial to public safety and public order, more specifically:
 - (i) Larceny of Motor Vehicle;
 - (ii) Robbery of personalty.

2. Ricardo Facey is to be detained from October 4, 2019 until the end of the period of the public emergency which commenced with the Proclamation of the Governor-General published in the Jamaica Gazette Supplement Proclamation, Rules and Regulations on the 30th day of April, 2019.

3. For the purposes of paragraph 11 of regulation 38, notice is hereby given as follows:

- (a) Ricardo Facey has been concerned in acts prejudicial to public safety and public order, more specifically:
 - (i) Larceny of motor vehicle;
 - (ii) Robbery of personalty;
 - (iii) Simple larceny.
- (b) Section 13(10) of the Constitution of Jamaica gives you the right to request a review of your case at any time during the period of your detention which is to be reviewed by The Emergency Powers Tribunal and Regulation 38(6) of the Emergency Powers Regulations, 2019 gives you the right to make objection against the Detention Order to the Emergency Powers Review Tribunal.
