**THE EMERGENCY POWERS REGULATIONS, 2019**

**THE DETENTION (GARREN LEVAR BRAHAM)**

**(STATE OF PUBLIC EMERGENCY FOR THE PARISH OF HANOVER) ORDER, 2019**

In exercise of the power conferred upon the Minister by regulations 33(1) and 38 of the Emergency Powers Regulations, 2019, the following Order is hereby made:—

1. This Order may be cited as the Detention Garren Levar Braham o/c Mark Shields o/c Curbis and o/c Speng Shell) (State of Public Emergency for the parish of Hanover) Order, 2019.
2. Garren Levar Braham o/c Mark Shields o/c Curbis and o/c Speng Shell, is to be detained from September 10, 2019 until the end of the period of the public emergency which commenced with the Proclamation of the Governor-General published in the Jamaica Gazette Supplement Proclamation, Rules and Regulations on the 30th day of April, 2019.

3. For the purposes of paragraph 11 of regulation 38, notice is hereby given as follows:

- (a) Garren Levar Braham o/c Mark Sheilds o/c Curbis and o/c Speng Shell, has been concerned in acts prejudicial to public safety and public order, more specifically:
  - (i) Illegal possession of firearm;
  - (ii) Illegal possession of ammunitons;
  - (iii) Illegal dealing of firearm and ammunition;
  - (iv) Extortion;
- (b) Section 13(10) of the Constitution of Jamaica gives you the right to request a review of your case at any time during the period of your detention which is to be reviewed by The Emergency Powers Tribunal and Regulation 38(6) of the Emergency Powers Regulations, 2019 gives you the right to make objection against the Detention Order to The Emergency Powers Review Tribunal.

3. For the purposes of paragraph 13 of regulation 38, notice is hereby given as follows:

(a) Jason Harris has been concerned in acts prejudicial to public safety and public order, more specifically:

(i) Suspected of being involved in the murder of Owen Brown committed on April 14, 2019, at Hudson Street, Savanna-la-Mar, Westmoreland, along with fellow gang members Courtney Hall and Odane Samuels; and

(ii) Suspected of being a member of a criminal organization; the “Delete Squad” gang.

(b) Section 13(10) of the Constitution of Jamaica gives you the right to request a review of your case at any time during the period of your detention which is to be reviewed by The Emergency Powers Tribunal and Regulation 38(9) of the Emergency Powers Regulations, 2019 gives you the right to make objection against the Detention Order to The Emergency Powers Review Tribunal.
