THE DETENTION (KEVAR WALKER O/C BLACK EAGLE)
(STATE OF PUBLIC EMERGENCY FOR THE PARISH OF WESTMORELAND)
ORDER, 2019

- 1. This Order may be cited as the Detention (Kevar Walker o/c Black Eagle) (State of Public Emergency for the parish of Westmoreland) Order, 2019.
- 2. Kevar Walker o/c Black Eagle is to be detained from August 30, 2019 until the end of the period of the public emergency which commenced with the Proclamation of the Governor-General published in the Jamaica Gazette Supplement Proclamation, Rules and Regulations on the 30th day of April, 2019.

- 3. For the purposes of paragraph 11 of regulation 38, notice is hereby given as follows:
 - (a) Kevar Walker o/c Black Eagle has been concerned in acts prejudicial to public safety and public order, more specifically:
 - i. Robbery with aggravation;
 - ii. Illegal possession of firearm;
 - iii. Receiving Stolen property;
 - iv. Assault at Common Law;
 - b. THE DETENTION (RAYON JOHNSON) (STATE OF PUBLIC EMERGENCY FOR THE PARISH OF WESTMORELAND) ORDER, 2019

In exercise of the power conferred upon the Minister by regulations 33(1) and 38 of the Emergency Powers Regulations, 2019, the following Order is hereby made:—

- 1. This Order may be cited as the Detention (Rayon Johnson) (State of Public Emergency for the parish of Westmoreland) Order, 2019.
- 2. Rayon Johnson is to be detained from August 30, 2019 until the end of the period of the public emergency which commenced with the Proclamation of the Governor-General published in the Jamaica Gazette Supplement Proclamation, Rules and Regulations on the 30th day of April, 2019.
 - 3. For the purposes of paragraph 11 of regulation 38, notice is hereby given as follows:
 - (a) Rayon Johnson has been concerned in acts prejudicial to public safety and public order, more specifically:
