THE EMERGENCY POWERS REGULATIONS, 2019

THE DETENTION (NICHOLAS HEATH O/C DUP DAP)  
(STATE OF PUBLIC EMERGENCY FOR THE PARISH OF SAINT ANDREW  
SOUTH DIVISION) ORDER, 2019

In exercise of the power conferred upon the Minister by regulations 33(1) and 38 of the Emergency Powers Regulations, 2019, the following Order is hereby made:—

1. This Order may be cited as the Detention (Nicholas Heath o/c Dup Dap) (State of Public Emergency for the parish of Saint Andrew South Division) Order, 2019.
2. Nicholas Heath o/c Dup Dap is to be detained from October 11, 2019 until the end of the period of the public emergency which commenced with the Proclamation of the Governor-General published in the Jamaica Gazette Supplement Proclamation, Rules and Regulations on the 7th day of July, 2019.
