THE DETENTION (ROBERT BOLAND) (STATE OF PUBLIC EMERGENCY FOR THE PARISHES OF ST. JAMES, HANOVER AND WESTMORELAND)

ORDER, 2019

In exercise of the power conferred upon the Minister by regulations 33 and 38 of the Emergency Powers Regulations, 2019, the following Order is hereby made:—

1. This Order may be cited as the Detention (Robert Boland) (State of Public Emergency for the Parishes of St. James, Hanover and Westmoreland) Order, 2019.

- 2. Robert Boland is to be detained from July 12, 2019 until the end of the period of the public emergency which commenced with the Proclamation of the Governor-General published in the Jamaica Gazette Supplement Proclamation, Rules and Regulations on the 30th day of April, 2019.
  - 3. For the purposes of paragraph 13 of regulation 38, notice is hereby given as follows:
    - (a) Robert Boland has been concerned in acts prejudicial to public safety and public order, more specifically:
      - i. Suspected of being involved in the murder of Mr. Sobers Mackerdy on October 27, 2018; and
      - ii. Suspected of being a member of a criminal organization, the "Dester Street" gang.
