THE EMERGENCY POWERS REGULATIONS, 2019

DETENTION (ODEAN BROWN) (STATE OF PUBLIC EMERGENCY FOR THE PARISHES
OF ST. JAMES, HANOVER AND WESTMORELAND) ORDER, 2019

In exercise of the power conferred upon the Minister by regulations 33 and 38 of the Emergency Powers Regulations, 2019, the following Order is hereby made:—

1. This Order may be cited as the Detention (Odean Brown) (State of Public Emergency for the Parishes of St. James, Hanover and Westmoreland) Order, 2019.
2. Odean Brown is to be detained from July 19, 2019 until the end of the period of the public emergency which commenced with the Proclamation of the Governor-General published in the Jamaica Gazette Supplement Proclamations, Rules and Regulations on the 30th day of April, 2019.

3. For the purposes of paragraph 13 of regulation 38, notice is hereby given as follows:
- (a) Odean Brown has been concerned in acts prejudicial to public safety and public order, more specifically:
 - (i) Wanted for the murder and wounding with intent of Allan Walters and Jermaine Byfield respectively committed on March 10, 2019;
 - (ii) Previously charged with shooting with intent and illegal possession of a firearm committed on November 21, 2016; and
 - (iii) Suspected of being a member of a criminal organization.
 - (b) Section 13(10) of the Constitution of Jamaica gives you the right to request a review of your case at any time during the period of your detention which is to be reviewed by The Emergency Powers Tribunal and Regulation 38(9) of the Emergency Powers Regulations, 2019 gives you the right to make objection against the Detention Order to The Emergency Powers Review Tribunal.
4. In accordance with paragraph 14 of regulation 38, please be advised of the following:
- (a) The Notice of Objection Form may be accessed from the commanding officer at your place of detention or online at mns.gov.jm.
 - (b) A completed Notice of Objection Form may be submitted to the Secretariat of the Emergency Powers Review Tribunal at The Wexford Hotel at 39 Gloucester Avenue, Montego Bay or via email to eptsecretariat@gmail.com.
 - (c) After the completed Notice of Objection Form has been submitted, you or your representative will be contacted and invited to a hearing where you may present your case to The Emergency Powers Review Tribunal.

DETENTION (CHRISTOPHER CHIN) (STATE OF PUBLIC EMERGENCY FOR THE PARISHES OF ST. JAMES, HANOVER AND WESTMORELAND) ORDER, 2019

In exercise of the power conferred upon the Minister by regulations 33 and 38 of the Emergency Powers Regulations, 2019, the following Order is hereby made:—

1. This Order may be cited as the Detention (Christopher Chin) (State of Public Emergency for the Parishes of St. James, Hanover and Westmoreland) Order, 2019.
2. Christopher Chin is to be detained from July 19, 2019 until the end of the period of the public emergency which commenced with the Proclamation of the Governor-General published

in the Jamaica Gazette Supplement Proclamations, Rules and Regulations on the 30th day of April, 2019.

3. For the purposes of paragraph 13 of regulation 38, notice is hereby given as follows:

- (a) Christopher Chin has been concerned in acts prejudicial to public safety and public order, more specifically:
 - (i) Charged for the offences of shooting with intent (four counts) and illegal possession of firearm committed on April 22, 2016;
 - (ii) Previously charged with shooting with intent committed on May 14, 2017; and
 - (iii) Suspected of being a member of a criminal organization.
- (b) Section 13(10) of the Constitution of Jamaica gives you the right to request a review of your case at any time during the period of your detention which is to be reviewed by The Emergency Powers Tribunal and Regulation 38(9) of the Emergency Powers Regulations, 2019 gives you the right to make objection against the Detention Order to The Emergency Powers Review Tribunal.

4. In accordance with paragraph 14 of regulation 38, please be advised of the following:

- (a) The Notice of Objection Form may be accessed from the commanding officer at your place of detention or online at mns.gov.jm.

3. For the purposes of paragraph 13 of regulation 38, notice is hereby given as follows:

- (a) Andre Hall has been concerned in acts prejudicial to public safety and public order, more specifically:
 - (i) Previously charged with shooting with intent and illegal possession of firearm committed on March 10, 2017;
 - (ii) Previously charged with shooting with intent and illegal possession of firearm committed on March 17, 2017;
 - (iii) Previously charged with shooting with intent and illegal possession of firearm committed on October 14, 2017; and
 - (iv) Suspected of being a member of a criminal organization.
- (b) Section 13(10) of the Constitution of Jamaica gives you the right to request a review of your case at any time during the period of your detention which is to be reviewed by The Emergency Powers Tribunal and Regulation 38(9) of the Emergency Powers Regulations, 2019 gives you the right to make objection against the Detention Order to The Emergency Powers Review Tribunal.

4. In accordance with paragraph 14 of regulation 38, please be advised of the following:
