THE EMERGENCY POWERS ACT

THE EMERGENCY POWERS REGULATIONS, 2020

DETENTION (PAUL CASSANOVA O/C PABLO)

(STATE OF PUBLIC EMERGENCY FOR THE PARISHES OF KINGSTON AND
ST. ANDREW) ORDER, 2020

In exercise of the power conferred upon the Minister by regulations 33(1) and 38 of the Emergency Powers Regulations, 2020, the following Order is hereby made:—

1. This Order may be cited as the Paul Cassanova o/c Pablo (State of Public Emergency for the parishes of Kingston and St. Andrew) Order, 2020.
2. Paul Cassanova o/c Pablo, is to be detained from April 17, 2020 until the end of the period of the public emergency which commenced with the Proclamation of the Governor-General published in the Jamaica Gazette Supplement Proclamations, Rules and Regulations on the 26th day of January, 2020.

3. For the purposes of paragraph 11 of regulation 38, notice is hereby given as follows:

- (a) Paul Cassanova o/c Pablo, has been concerned in acts prejudicial to public safety and public order, more specifically that he is suspected of the following:
 - (i) Being the leader of a criminal organization known as the Los Angeles/Crusher/Fully Govern Gang operating in the Bayshore Park community of Kingston 17.
 - (ii) Orchestrating the murder of Mr. Lorenzo Hinds o/c Lanz on February 3, 2018 in the Bayshore Park community where Mr. Hinds was shot and killed at his home and where his two-year-old son was injured.
 - (iii) Participating in the murder of Mr. Garrett Williams o/c Finger, who was an alleged close friend of Mr. Lorenzo Hinds on February 23, 2018, in the Crusher area of the Bayshore Park community.
 - (iv) Being involved in a violent dispute with Morice Yearg o/c Indian. This dispute has resulted in the conviction of Mr. Cassanova for the offence of Assault Occasioning Actual Bodily Harm in 2018, committed against Mr. Yearg.
 - (v) Giving orders to Mr. Durrant Shorter o/c Bulbie to murder Mr. Dennis McIntosh o/c Schoolaz. Mr. McIntosh was murdered on June 26, 2019 and Mr. Shorter has been charged with his murder.
 - (vi) Being involved in a violent dispute with a former member of his gang known as "Lucas" which has resulted in:
 - (a) The murder of Justin Foster, the brother of "Lucas" on November 17, 2019, in the Bayshore Park area; and
 - (b) A retaliation shooting for the murder of Mr. Foster committed at a party in the Bayshore Park area on November 23, 2019, where Mr. Cassanova and members of his gang were present. Eight persons were shot; two of which were pronounced dead.
 - (vii) Charged with the offences of Wounding with Intent, Illegal Possession of Firearm and Illegal Possession of Ammunition arising from the shooting of Mr. Karnal Shaw, the brother of the now deceased Mr. Dennis McIntosh o/c Schoolaz and Mr. Roger Dunbar on January 13, 2020. This matter is currently before the court.
- (b) Section 13(10) of the Constitution of Jamaica gives you the right to request a review of your case at any time during the period of your detention which is to be reviewed by The Emergency Powers Tribunal and Regulation 38(6) of the Emergency Powers Regulations, 2019, gives you the right to make objection against the Detention Order to The Emergency Powers Review Tribunal.

4. In accordance with paragraph 12 of regulation 38, please be advised of the following:

- (a) The Notice of Objection Form may be accessed from the commanding officer at your place of detention or online at mns.gov.jm.
- (b) A completed Notice of Objection Form may be submitted to the Secretariat of the Emergency Powers Review Tribunal at the Ministry of National Security, Fourth (4th) Floor, NCB Towers, North Tower, 2 Oxford Road, Kingston 5, St. Andrew or via email to eastkingstonERT@gmail.com.
- (c) After the completed Notice of Objection Form has been submitted, you or your representative will be contacted and invited to a hearing where you may present your case to The Emergency Powers Review Tribunal.
