THE EMERGENCY POWERS ACT

THE EMERGENCY POWERS REGULATIONS, 2018

THE EMERGENCY POWERS (PARISH OF ST. JAMES) (OPENING HOURS OF ESTABLISHMENTS) ORDER, 2018

In exercise of the power conferred upon the Minister of National Security by regulation 37 of the Emergency Powers Regulations, 2018 (the Minister being an authorized person as defined by regulation 2(1) of those Regulations), the following Order is hereby made:—

1. This Order may be cited as the Emergency Powers (Parish of St. James) (Opening Hours of Establishments) Order, 2018.

2. Except as provided in paragraph 3, the following establishments shall be closed and remain closed except during the hours, and for the purposes, specified as follows—

Description of Establishment	Opening Hours —	Purpose
Clubs and fast food restaurants	From 6:00 a.m. until 2:00 a.m.	The normal operations of the establishment.
Every place required by law to operate under a tavern licence	From 7:00 a.m. until 10:00 p.m.	The normal operations of the establishment.
3. Petroleum filling stations	From 6:00 a.m. until 11:00 p.m.	The normal operations of the establishment.
4. Supermarkets, grocery shops, haberdasheries and any other place (other than a place referred to in any other paragraph of this table) offering goods for sale	From 6:00 a.m. until 8:00 p.m.	The normal operations of the establishment.
5. Pharmacies	From 6:00 a.m. until 10:00 p.m.	The normal operations of the establishment.
6. Any other public place, except a tourism enterprise or tourist accommodation as defined in the <i>Tourist Board Act</i>	From 7:00 a.m. until 10:00 p.m.	The normal operations of the establishment.


The area having the boundaries described in Part A of this Schedule and depicted on the map set out in Part B of this Schedule.

PART A

- North An imaginary line running westerly from the Airport Roundabout, through the Airport, across Kent Avenue, and into the sea, covering the seaward approaches to Freeport out to Grid 18.48 N and -77.93 W.
- South An imaginary line running westerly from the stoplight at the ATL Complex, across Bogue Road, through the swamp area, and into the sea covering the seaward approaches to Freeport out to Grid 18.49 N and -77.94 W.
- East From the Airport Roundabout, south along Queens Drive, south along St. James Street to Barnett Street, south-westerly along Barnett Street to Bogue Road, south along Bogue Road to the stoplight at the ATL Complex.
- West A straight line between Grids 18.48 N and -77.93 W, 18.49 N and -77.94 W (incorporating Freeport).
