THE EMERGENCY POWERS ACT

THE EMERGENCY POWERS REGULATIONS, 2019

THE EMERGENCY POWERS (PARISHES OF ST. JAMES, HANOVER AND WESTMORELAND)
(OPENING HOURS OF ESTABLISHMENTS) (TEMPORARY AMENDMENT)
(No. 2) ORDER, 2019

In exercise of the power conferred upon the Minister of National Security by regulation 37 of the Emergency Powers Regulations, 2019 (the Minister being an authorized person as defined by regulation 2(1) of those Regulations), the following Order is hereby made:—

- 1. This Order may be cited as the Emergency Powers (Parishes of St. James, Hanover and Westmoreland) (Opening Hours of Establishments) (Temporary Amendment) (No. 2) Order, 2019.
- 2. During the period from the 2nd day of August, 2019 to the 7th day of August, 2019, the Emergency Powers (Parishes of St. James, Hanover and Westmoreland) (Opening Hours of Establishments) Order, 2019 (hereinafter referred to as the principal Order), shall be read and construed with the amendments set out in paragraph 3.

- 3. Insert next after paragraph 2 of the principal Order the following paragraph and schedule—
 - " 3. During the period from the 2nd day of August, 2019 to the 7th day of August, 2019, establishments within the area described in the Schedule are excluded from the operation of paragraph 2.

SCHEDULE

(Paragraph 3)

Area exempt from paragraph 2 during the period August 2 through 7, 2019

1. The area having the boundaries described in Part A of this Schedule and depicted on the map set out in Part B of this Schedule.

PART A

North — From a point in the Caribbean Sea in the vicinity of Salt Creek Bridge (Latitude 18°21'48.86"N, Longitude 78°20'20.58"W), travelling along an imaginary line across the Norman Manley Boulevard to a forest/Swampy area (Latitude 18°21'52.76"N, Longitude 78°18'47,59"W).

East — From the forest/Swampy area (Latitude 18°21'52.76"N, Longitude 78°18'47.59"W), running along an imaginary line to the forest area in a community within West End (Latitude 18°15'14.32"N, Longitude 78°21'22.30"W).


South — From the forested area in a community within West End (Latitude 18°15'14.32"N, Longitude 78°21'22.30"W), running along an imaginary line across the West End roadway and adjacent Rick's Cafe into the Caribbean Sea (Latitude 18°15'15.15"N, Longitude 78°21'48.29"W).

West — From a point in the Caribbean Sea (Latitude 18°15'15.15"N, Longitude 78°21'48.29"W), running along an imaginary line in the said Caribbean Sea in the vicinity of Salt Creek Bridge (Latitude 18°21'48.86"N, Longitude 78°20'20.58"W).
