THE EMERGENCY POWERS REGULATIONS, 2018

**THE EMERGENCY POWERS DETENTION (AKEEM DEHANEY) (STATE OF PUBLIC
EMERGENCY FOR THE PARISH OF ST. JAMES) ORDER, 2018**

In exercise of the power conferred upon the Minister by regulations 33 and 38 of the Emergency Powers Regulations, 2018, the following Order is hereby made:—

1. This Order may be cited as the Emergency Powers Detention (Akeem Dehaney) (State of Public Emergency for the Parish of St. James) Order, 2018.
2. Akeem Dehaney is to be detained from July 3, 2018 until the end of the period of the public emergency which commenced with the Proclamation of the Governor-General published in the Jamaica Gazette Supplement Proclamations, Rules and Regulations on the 18th day of January, 2018.

3. For the purposes of paragraph 11 of regulation 38, notice is hereby given as follows:

- (a) Akeem Dehaney has been concerned in acts prejudicial to public safety and public order, more specifically:
 - (i) Illegal possession and sale of firearms and ammunitions;
 - (ii) Double murder of Frank and Dilean Nelson on 31.7.2017;
 - (iii) Wounding with intent of Jenroy Ritchie committed at Ramble Hill, St. James;
 - (iv) Threatening the lives of police personnel and their families;
 - (v) Being a key member of a criminal gang;
 - (vi) Murder of Romario Moore in Codac Drive, Flankers, St. James on 7.5.2016;
 - (vii) Murder of Imran Barrett in Central Avenue, Flankers, St. James on the 04.05.2016; and
 - (viii) Involved in gang activity.
- (b) Section 13(10) of the Constitution of Jamaica gives you the right to request a review of your case at any time during the period of your detention which is to be reviewed by the Emergency Powers Tribunal and Regulation 38(6) of the Emergency Powers Regulations, 2018 gives you the right to make objection against the Detention Order to the Emergency Powers Review Tribunal.

4. In accordance with paragraph 12 of regulation 38, please be advised of the following:

- (a) The Notice of Objection Form may be accessed from the commanding officer at your place of detention or online at mns.gov.jm.

- (c) After the completed Notice of Objection Form has been submitted, you or your representative will be contacted and invited to a hearing where you may present your case to the Emergency Powers Review Tribunal.

THE EMERGENCY POWERS DETENTION (TAVOY BURNETT) (STATE OF PUBLIC
EMERGENCY FOR THE PARISH OF ST. JAMES) ORDER, 2018

In exercise of the power conferred upon the Minister by regulations 33 and 38 of the Emergency Powers Regulations, 2018, the following Order is hereby made:—

1. This Order may be cited as the Emergency Powers Detention (Tavoy Burnett) (State of Public Emergency for the Parish of St. James) Order, 2018.

2. Tavoy Burnett is to be detained from July 3, 2018 until the end of the period of the public emergency which commenced with the Proclamation of the Governor-General published in the Jamaica Gazette Supplement Proclamations, Rules and Regulations on the 18th day of January, 2018.

3. For the purposes of paragraph 11 of regulation 38, notice is hereby given as follows:

(a) Tavoy Burnett has been concerned in acts prejudicial to public safety and public order, more specifically:

- (i) Double murder of Fahdeal Farquason and Odaine Graham committed on 20/04/2018 in Spring Mountain, St. James;
- (ii) Double murder of Canute Dennis and Oraine Dunkley committed on 13.10.2013 in Spring Mountain, St. James;
- (iii) Murder of Dalton Vaughn committed in Johns Hall, St. James on 13.03.2016;
- (iv) Shooting of Anthonique Hall in Coconut walk on 14.08.2017;
- (v) Shooting of Oniel McIntosh in Coconut walk on 5.8.2017;
- (vi) Shooting of Austin Maxwell in Johns Hall on 8.5.2017;
- (vii) Shooting of Josly Coote in Village Johns Hall on 20.2.2014; and
- (viii) Involved in lottery scamming and gang financing activities.

(b) Section 13(10) of the Constitution of Jamaica gives you the right to request a review of your case at any time during the period of your detention which is to be reviewed by The Emergency Powers Tribunal and Regulation 38(6) of the Emergency Powers Regulations, 2018 gives you the right to make objection against the Detention Order to The Emergency Powers Review Tribunal.

 - (iv) Being the leader of the ISIS Gang, a criminal gang; and
 - (v) Involved in lotto scamming.
