**THE EMERGENCY POWERS DETENTION (OBRIAN JAVON BROWN) (STATE OF
PUBLIC EMERGENCY FOR THE PARISH OF ST. JAMES) ORDER, 2018**

In exercise of the power conferred upon the Minister by regulations 33 and 38 of the Emergency Powers Regulations, 2018, the following Order is hereby made:—

1. This Order may be cited as the Emergency Powers Detention (Obrian Javon Brown) (State of Public Emergency for the Parish of St. James) Order, 2018.

2. Obrian Javon Brown is to be detained from November 9, 2018 until the end of the period of the public emergency which commenced with the Proclamation of the Governor-General published in the Jamaica Gazette Supplement Proclamations, Rules and Regulations on the 18th day of January, 2018.

3. For the purposes of paragraph 11 of regulation 38, notice is hereby given as follows:

- (a) Obrian Javon Brown has been concerned in acts prejudicial to public safety and public order, more specifically:
 - (i) Charged and convicted for Wounding with Intent, Illegal Possession of Firearm and Malicious Destruction of Property committed on November 22, 2014 in St. Ann;
 - (ii) Assaulted Ryan Scott with an illegal firearm on August 9, 2018 along Salem Main Road; and
 - (iii) Previously taken into custody due to complaints of extortionist behavior.
- (b) Section 13(10) of the Constitution of Jamaica gives you the right to request a review of your case at any time during the period of your detention which is to be reviewed by The Emergency Powers Tribunal and Regulation 38(6) of the Emergency Powers Regulations, 2018 gives you the right to make objection against the Detention Order to The Emergency Powers Review Tribunal.

4. In accordance with paragraph 12 of Regulation 38, please be advised of the following:

- (a) The Notice of Objection Form may be accessed from the commanding officer at your place of detention or online at mns.gov.jm.

In exercise of the power conferred upon the Minister by Regulations 33 and 38 of the Emergency Powers Regulations, 2018, the following Order is hereby made:—

- 1. This Order may be cited as the Emergency Powers Detention (Onico Phillip Cruddock) (State of Public Emergency for the Parish of St. James) Order, 2018.

2. Onico Phillip Cruddock is to be detained from November 9, 2018 until the end of the period of the public emergency which commenced with the Proclamation of the Governor-General published in the Jamaica Gazette Supplement Proclamations, Rules and Regulations on the 18th day of January, 2018.

3. For the purposes of paragraph 11 of regulation 38, notice is hereby given as follows:

- (a) Onico Phillip Cruddock has been concerned in acts prejudicial to public safety and public order, more specifically:
 - (i) Arrested for the shooting of Mr. Carl Gunn in Mud Valley, Retirement, St. James in February, 2017;
 - (ii) Arrested for arson committed on March 29, 2017;
 - (iii) Murder of Kemar Lewis committed on July 24, 2017 at Gunn's Drive, Granville, St. James;
 - (iv) Illegal Possession of Firearm;
 - (v) Wounding with Intent of Derrel Nugent on November 13, 2017 along Browns Lane; and
 - (vi) Being a criminal gang leader, Garage Turn gang.
- (b) Section 13(10) of the Constitution of Jamaica gives you the right to request a review of your case at any time during the period of your detention which is to be reviewed by The Emergency Powers Tribunal and Regulation 38(6) of the Emergency Powers Regulations, 2018 gives you the right to make objection against the Detention Order to The Emergency Powers Review Tribunal.

(iii) Suspected of being a key member of a Gang; and

(iv) Believed to be an extortionist.

(b) Section 13(10) of the Constitution of Jamaica gives you the right to request a review of your case at any time during the period of your detention which is to be reviewed by The Emergency Powers Tribunal and Regulation 38(6) of the Emergency Powers Regulations, 2018 gives you the right to make objection against the Detention Order to The Emergency Powers Review Tribunal.

 - (ii) Murder of Damaine Samuels on April 19, 2018;
 - (iii) Murder of Ron Samuels in Costa Rica on April 21, 2018;
 - (iv) Illegal Possession of Firearm;
 - (v) Being a criminal gang leader, Wrong Turn gang;
 - (vi) Murder of Romario Moore in Codac Drive, Flankers, St. James on 7.5.2016;
 - (vii) Involved in lottery scamming.

 - (iv) Suspected of being a key member of the Alliance Gang; and
 - (v) Confirmed as being an extortionist.
- (b) Section 13(10) of the Constitution of Jamaica gives you the right to request a review of your case at any time during the period of your detention which is to be reviewed by The Emergency Powers Tribunal and Regulation 38(6) of the Emergency Powers Regulations, 2018 gives you the right to make objection against the Detention Order to The Emergency Powers Review Tribunal.

2. Andrew Smith is to be detained from November 9, 2018 until the end of the period of the public emergency which commenced with the Proclamation of the Governor-General published in the Jamaica Gazette Supplement Proclamations, Rules and Regulations on the 18th day of January, 2018.

3. For the purposes of paragraph 11 of regulation 38, notice is hereby given as follows:

- (a) Andrew Smith has been concerned in acts prejudicial to public safety and public order, more specifically:
 - (i) involved in an altercation with Tylor Hylton on March 30, 2018 in which a firearm was used;
 - (ii) Assaulted and battered a man in August, 2018 and dealing in ganja;
 - (iii) Arrested and charged for a murder committed in Westmoreland in 2016;
 - (iv) Suspected of being involved in numerous murders and shootings;
 - (v) Suspected of being a key member of the Top Junglist Gang; and
 - (vi) Confirmed as being an extortionist.
- (b) Section 13(10) of the Constitution of Jamaica gives you the right to request a review of your case at any time during the period of your detention which is to be reviewed by The Emergency Powers Tribunal and Regulation 38(6) of the Emergency Powers Regulations, 2018 gives you the right to make objection against the Detention Order to The Emergency Powers Review Tribunal.
