THE EMERGENCY POWERS DETENTION (RENIEL ONIEL MILLS) (STATE OF PUBLIC EMERGENCY FOR THE PARISH OF ST. JAMES) ORDER, 2018

In exercise of the power conferred upon the Minister by regulations 33 and 38 of the Emergency Powers Regulations, 2018, the following Order is hereby made:—

- (iii) Three counts of wounding with intent committed on 4th June, 2017 at Valley Heights, Green Pont, St. James;
