## THE FIREARMS ACT

THE FIREARMS (DELIVERY OF FIREARMS AND AMMUNITION) (ORVILLE HENRIQUES) NOTIFICATION, 2018

WHEREAS section 36(l)(a) of the Firearms Act (hereinafter referred to as "the Act"), provides that subject to section 37 of the Act, the Firearms Licensing Authority (hereinafter referred to as "the Authority"), may revoke any licence, certificate or permit if the Authority is satisfied that the holder thereof is unfit to be entrusted with such firearm or ammunition as may be mentioned in the licence, certificate or permit:

AND WHEREAS section 36(2) of the Act provides that where the Authority revokes any licence, certificate or permit under this section or under section 18 or 46, the Authority shall give notice in writing thereof—

- (a) specifying that the Authority has revoked such licence, certificate or permit; or
- (b) requiring such person to deliver up such licence, certificate or permit to the Authority on or before the day (not being less than three days after the delivery of such notice) specified in such notice:

AND WHEREAS by virtue of section 36(2) of the Act, the Authority gave notice to Mr. Orville Henriques by revocation order dated July 9th, 2018, of the revocation of all the firearms licences issued to him by the Authority pursuant to section 36(l)(a) on the grounds of being unfit to be entrusted with such firearms and ammunition mentioned in the licences in relation thereto:

AND WHEREAS by virtue of section 36(2) of the Act, Mr. Orville Henriques, without a licence, remains in possession and full control of hundreds of firearms and thousands of rounds of assorted ammunition:

AND WHEREAS section 35A(1) of the Act provides that where the Minister is satisfied that it is in the interest of national security so to do, he may by notification in accordance with subsection (2), require the delivery to the Authority, of such firearms and ammunition as may be specified in the notification, subject to such terms and conditions as may be specified in that notification:

AND WHEREAS subsection (2) of section 35A of the Act provides a notification pursuant to subsection (1) of section 35A, shall be published in the *Gazette* and in a daily newspaper published and circulating in Jamaica, and upon a notification being so published, any person to whom the requirement contained therein applies shall, within fourteen days from the date of such publication, deliver any firearm and ammunition to which the notification relates, to the Authority for safekeeping:

AND WHEREAS by virtue of section 35A(1) of the Act, the Minister intends to exercise his power for the delivery to the Authority of all firearms and ammunition in possession and control of Mr. Orville Henriques of 13 Wint Terrace, Mandeville, in the parish of Manchester:

NOW THEREFORE, in exercise of the power conferred upon the Minister by section 35A(1) of the Firearms Act, the following notification is hereby made:—

- 1. This notification may be cited as the Firearms (Delivery of Firearms and Ammunition) (Orville Henriques) Notification, 2018.
- 2. All firearms and ammunition in respect of licences 2013-012524; 2013-012526; 2013-012527; 2013-012535; 2015-040440; 2015-044059; 2016-048005; 2017-051425; 2018-52810; FDLR/009/2017; FDLR/017/2017; FLA-AFT010/07 and GDL/008/2017, revoked on July 9th, 2018, in the possession and control of Mr. Orville Henriques of 13 Wint Terrace, Mandeville, in the parish of Manchester, shall, be delivered to the Firearms Licensing Authority, at 91A Old Hope Road, Kingston 6, no later than fourteen days from the date of this publication of this notification.
