THE HOUSING ACT

(Act 55 of 1968)

THE HOUSING SCHEME PART OF HAGUE AND CLIFTON IN THE PARISH OF TRELAWNY (HOUSING AREA) ORDER, 2019

In exercise of the powers conferred upon the Minister by section 4(1) of the Housing Act, and every other power hereunto enabling, the following Order is hereby made:—

- 1. This Order may be cited as the Housing Scheme part of Hague and Clifton in the parish of Trelawny (Housing Area) Order, 2019.
- 2. By this Order the land described in the Schedule hereto is hereby declared a Housing Area.

SCHEDULE

All that part of land of part of Hague and Clifton in the parish of Trelawny registered at Volume 1430 Folio 650 containing by survey 9.5867 hectares.
