**THE HOUSING ACT**

(Act 55 of 1968)

THE HOUSING SCHEME PART OF DIRLTON ALSO KNOWN AS ROCKHAMPTON  
SITUATED AT GALINA IN THE PARISH OF SAINT MARY  
(HOUSING AREA) ORDER, 2018

In exercise of the powers conferred upon the Minister by section 4(1) of the Housing Act, and every other power hereunto enabling, the following Order is hereby given:—

1. This Order may be cited as the Housing Scheme part of Dirlton, also known as Rockhampton situated at Galina in the parish of Saint Mary (Housing Area) Order 2018.
2. By this Order the land described in the Schedule hereto is hereby declared a Housing Area.

SCHEDULE

All those parcels of land, being the Lots Numbered 1 and 2 on the Proposed Subdivision Plan of part of Dirlton also known as Rockhampton situated at Galina in the parish of Saint Mary, registered at Volume 1343 Folio 326 in the Registered Book of Titles, containing by survey 32.0279 hectares (79.14 acres) of land, be the same more or less.

The property is butted and bounded:

- Northerly: on land registered at Volume 1070 Folio 287 in the name of Barbara Pryce; lands registered at Volume 1443 Folio 792 in the name of Irene Plummer; lands in the possession of Dirlton Galina Village Homes Limited, partly registered at Volume 1172 Folio 34 and partly unregistered; lands registered Volume 1144 Folio 569 in the name of Inez Hay *et al*; lands registered at Volume 939 Folio 135 in the name of Reuben Barriffe; lands in the possession of Barbara Douglas *et al*; partly registered at Volume 1374 Folio 526 and partly unregistered; lands registered at Volume 1297 Folio 881 in the name of Vadne Ambrose *et al*; and on Section 1A — reserved for improvement on the Main Road leading from Oracabessa to Port Maria; and on Lots 3 and 5, registered at Volume 1343 Folio 326;
