THE INCOME TAX ACT

THE INCOME TAX (PRESCRIBED FORMS) (AMENDMENT) (No. 2) ORDER, 2020

In exercise of the power conferred upon the Commissioner General by sections 66(2) and 67(5) of the Income Tax Act, and of every other power hereunto enabling, the following Order is hereby made:—

- 1. This Order may be cited as the Income Tax (Prescribed Forms) (Amendment) (No. 2) Order, 2020, and shall be read and construed as one with the Income Tax (Prescribed Forms) Order, 2015 (hereinafter referred to as the principal Order) and all amendments thereto.
- 2. Paragraph 2 of the principal Order is amended by inserting next after sub-paragraph (e) the following as sub-paragraph (f)—
 - "(f) Form P45 is the certificate prescribed for the purpose of the detailed specification by an employer of an employee's cumulative emoluments, tax deductions, statutory deductions, and the deduction of contributions to a pension, an approved superannuation fund and an approved retirement scheme.".

3. The Schedule to the principal Order is amended by inserting in the appropriate alphanumeric sequence the following form set out as Form P45—
