THE BETTING, GAMING AND LOTTERIES ACT

INSTRUMENT OF DELEGATION OF CERTAIN FUNCTIONS OF THE BETTING, GAMING AND LOTTERIES COMMISSION

WHEREAS IT IS PROVIDED in Subsection (1) of section 11 of the Betting, Gaming and Lotteries Act that the Betting, Gaming and Lotteries Commission may delegate to any person any of the functions exercisable by the Commission by virtue of the Betting, Gaming and Lotteries Act and subject to such conditions as may be specified:

AND WHEREAS IT IS PROVIDED by subsection (1) of section 11 of the Betting, Gaming and Lotteries Act that any delegation under subsection (1) of section 11 of the Betting, Gaming and Lotteries Act shall be revocable by the Commission:

NOW THIS DEED WITNESSETH AS FOLLOWS:

1. Appointment of:

Antoinette McKain, Jamaica Deposit Insurance Corporation, 30 Grenada Crescent, Kingston 5, Attorney-at-Law.

Ronald Young, Suite 9 and 10, 47E Old Hope Road, Kingston 5, Attorney-at-Law.

Helen Christian, 2A Bamboo Avenue, Townhouse No.11, Kingston 6, Management Consultant.

Emile Leiba, DunnCox, 48 Duke Street, Kingston, Attorney-at-Law: effective February 1, 2018 to January 31, 2020.

2. This delegation is made subject to:-

- (i) the condition that the functions hereby delegated shall be exercised by the delegatees in accordance with the general directions which may from time to time be given by the Commission:
- (ii) the condition that in the performance of the functions hereby delegated the quorum of the delegatees shall not be less than three (3):
- (iii) the condition that in the performance of the functions hereby delegated the said Antoinette McKain shall be the Chairman of each and every meeting of the delegates and shall preside over such meeting and if the said Antoinette McKain is absent from a meeting the delegates present at such meeting shall elect one of their member to preside over the meeting:
- (iv) the condition that the decisions of the delegatees shall be by way of a majority of the votes of those present at the meeting and in addition to an original vote the person presiding shall have a casting vote in any case in which the voting is equal: and
- (v) the provisions of subsection (2) and (3) of section 11 of the Betting, Gaming and Lotteries Act.

SCHEDULE

The functions hereby delegated are:

- those under Section 9 of the Betting, Gaming and Lotteries Act (hereinafter called "the Act"):
- (ii) those under paragraphs (a),(b) and (c) of Section 10 of the Act:
- (iii) without prejudice to the generality of sub-paragraph (ii) of this paragraph, those under paragraphs (a), (b) and (c) of section 10 and under section 22 of the Act as they relate to the investigation into the conduct of any licensee or the breach by any licensee or any servant or agent of the

licensee of any of the terms and conditions specified in any license, permit, approval or authority granted by the Commission and any of the rules set out in the Second, Third and Fifth Schedules of the Act:

(iv) those under paragraphs (a), (b) and (c) of section 10 of the Act as they relate to the investigation into any complaint made against a person holding a licence, permit, approval or authority granted by the Commission.
