THE JUDICATURE (RULES OF COURT) ACT

THE JAMAICA COURT OF APPEAL RULES (AMENDMENT), 2020

In exercise of the powers conferred upon the Rules Committee of the Supreme Court by section 4 of the Judicature (Rules of Court) Act, the following Rules are made:—

1. Citation

These Rules may be cited as the Jamaica Court of Appeal Rules (Amendment) 2020 and shall be read and construed as one with the Jamaica Court of Appeal Rules 2002 ("the Appeal Rules"), and all amendments thereto.

2. Commencement

These rules shall come into effect on August 1, 2020.

3. Amendment of Rule 1.8

Rule 1.8 of the Appeal Rules is amended by inserting next after paragraph (8)(b) as paragraph (8)(c) the following—

"(c) direct that the hearing of the application for permission to appeal be treated as the hearing of the appeal."

4. Amendment of Rule 1.14

Rule 1.14 of the Appeal Rules is amended by inserting next after paragraph (1) as paragraph (2) the following—

"(2) On the recommendation of the registrar, a single judge may dispense with any procedural requirement if satisfied that such an order should be made."

5. Amendment of Rule 1.18

Rule 1.18 of the Appeal Rules is amended at paragraph (4) by deleting the following—
", 65.8(3)"

6. Amendment of Rule 2.5

Rule 2.5 of the Appeal Rules is amended at paragraph (l)(a) by deleting "a single judge" and substituting the following—

"the court"

7. Amendment of Rule 2.4

Rule 2.4 of the Appeal Rules is amended—

(a) at paragraph (2) by deleting the words "the notice of appeal" and substituting the following—

"the appellant's submissions"; and

(b) at paragraph (7) by deleting the following—

"in keeping with the Practice Direction No. 1 of 2014 issued by the President of the Court of Appeal on 27th May, 2014.".

8. Amendment of Rule 2.9

Rule 2.9 of the Appeal Rules is amended—

- (a) at paragraph (1) by inserting after the word "writing" the following—
 "in form D1"
- (b) at paragraph (3) by deleting the "rule 2.9" and substituting the following—
 "rule 2.8"

9. Amendment of Rule 4.5

Rule 4.5 of the Appeal Rules is amended—

- at paragraph (1)(b)(ii) by deleting the following-
 - "and must if so directed by the court, obtain and keep for the use of the court any document or exhibit";
- by inserting next after paragraph (1)(b)(ii) as paragraph (1)(b)(iii) the following— (b)
 - "(iii) and must, if so directed by the court," and
- (c) by inserting next after paragraph (1)(b)(iii) the following-
 - "obtain and keep for the use of the court any document or exhibit".
- 10. Amendment of Appendix A to insert Form D1

Appendix A of the Appeals Rules is amended-

- by inserting next after Part 3 the following-
 - "Appendix A Part 4-Notice of Application for Court Orders"; and
- (b) inserting as Form D1 the following Form-

- (a) deleting the figures in Appendix B, Basic Costs and subtituting the following figures in the same order—
 - "(1) \$180,000 and \$48,000; (2)\$152,000 and \$48,000; (3) \$128,000 and \$48,000; (4) \$270,000 and \$96,000; (5) \$228,000 and \$96,000; (6) \$192,000 and \$96,000 (7) \$24,000; (8) \$40,000; (9) "\$24,000."; and (10) "\$12,000";
- (b) deleting under the heading "Note" the figure "\$6,000" and substituting the following—

"\$12,000.00"
