#### THE JUDICATURE (SUPREME COURT) ACT

THE JUDICATURE (CIRCUIT COURTS) (TIME AND PLACES FOR THE HOLDING THEREOF) ORDER, 2018

In exercise of the powers conferred on the Chief Justice by subsection (1) of section 31 of the Judicature (Supreme Court) Act, the following Order is hereby made:—

1. This Order may be cited as the Judicature (Supreme Courts) (Times and Places for the Holding Thereof) (Amendment) Order, 2018 and shall come into operation on the 1st day of January, 2019.
