#### THE JUDICATURE (SUPREME COURT) ACT

THE JUDICATURE (CIRCUIT COURTS) (TIMES AND PLACES FOR THE HOLDING THEREOF) ORDER, 2018

In exercise of the power conferred on the Chief Justice by subsection (1) of section 31 of the Judicature (Supreme Court) Act, the following Order is hereby made:—

- 1. This Order may be cited as the Judicature (Circuit Courts) (Times and Places for the holding thereof) Order, 2018, and shall come into operation on the 7th day of January, 2020.
- 2. The times and places for the holding of Circuit Courts for the year 2020 shall be set out in the Schedule hereto.
