Extract from the Minutes of the meeting of the Honourable House of Representatives held on Tuesday, June 12, 2018:

PUBLIC BUSINESS

The Most Honourable Andrew Holness, Prime Minister, having obtained suspension of the Standing Orders, moved:

WHEREAS section 4 of the Law Reform (Zones of Special Operations) (Special Security and Community Development Measures) Act, 2017 (hereinafter referred to as the Act), provides that the Prime Minister in Council may, by order, declare any geographically defined area within a single continuous boundary in Jamaica, as a zone of special operations for a period not exceeding sixty days if there are reasonable grounds to believe that due to rampant criminality, gang warfare, escalating violence and murder and the threat to the rule of law and public order, it is necessary so to do:

AND WHEREAS, in accordance with that section, the Prime Minister in Council made the Law Reform (Zones of Special Operations) (Special Security and Community Development Measures) (Declaration of the Denham Town Community Zone) (No. 2) Order, 2017:
