The Most Honourable Andrew Holness, Prime Minister and Minister of Defence, Minister of Economic Growth and Job Creation and Minister of Science and Technology, having obtained suspension of the Standing Orders, moved:

## THE LAW REFORM (ZONES OF SPECIAL OPERATIONS) (SPECIAL SECURITY AND COMMUNITY DEVELOPMENT MEASURES) ACT, 2017

THE LAW REFORM (ZONES OF SPECIAL OPERATIONS) (SPECIAL SECURITY AND COMMUNITY DEVELOPMENT MEASURES) (THE MOUNT SALEM COMMUNITY AND ENVIRONS IN THE PARISH OF SAINT JAMES ZONE) EXTENSION OF PERIOD OF OPERATIONS (No. 5) ORDER RESOLUTION, 2018

WHEREAS section 4 of the Law Reform (Zones of Special Operations) (Special Security and Community Development Measures) Act, 2017 (hereinafter referred to as the Act), provides that

the Prime Minister in Council may, by order, declare any geographically defined area within a single continuous boundary in Jamaica, as a zone of special operations for a period not exceeding sixty days if there are reasonable grounds to believe that due to rampant criminality, gang warfare, escalating violence and murder and the threat to the rule of law and public order, it is necessary so to do:

AND WHEREAS, in accordance with that section, the Prime Minister in Council made the Law Reform (Zones of Special Operations) (Special Security and Community Development Measures) (The Mount Salem Community and Environs in the Parish of Saint James Zone) Order, 2017:

AND WHEREAS that Order provides that the said zone shall operate for a period of sixty days:

AND WHEREAS section 5 of the Act provides that the Prime Minister in Council, after consultation with the Joint Command, may by order subject to affirmative resolution of the House of Representatives extend the said period for such further periods, each not exceeding sixty days:

AND WHEREAS on the 16th day of October, 2018, the Prime Minister in Council made the Law Reform (Zones of Special Operations) (Special Security and Community Development Measures) (The Mount Salem Community and Environs in the Parish of Saint James Zone) Extension of Period of Operation (No. 5) Order, 2018:

NOW THEREFORE, BE IT RESOLVED by this Honourable House as follows:-

- 1. This Resolution may be cited as the Law Reform (Zones of Special Operations) (Special Security and Community Development Measures) (The Mount Salem Community and Environs in the Parish of Saint James Zone) Extension of Period of Operation (No. 5) Order Resolution, 2018.
- 2. The Law Reform (Zones of Special Operations) (Special Security and Community Development Measures) (The Mount Salem Community and Environs in the Parish of Saint James Zone) Extension of Period of Operation (No. 5) Order, 2018, is hereby affirmed.

- 1. This Order may be cited as the Law Reform (Zones of Special Operations) (Special Security and Community Development Measures) (The Mount Salem Community and Environs in the Parish of Saint James Zone) Extension of Period of Operation (No. 5) Order, 2018.
- 2. The period of operation of the Mount Salem Community and Environs in the Parish of Saint James Zone—
  - (a) referred to in the Law Reform (Zones of Special Operations) (Special Security and Community Development Measures) (The Mount Salem Community and Environs in the Parish of Saint James Zone) Order, 2017, declared by the Prime Minister in Council on the 1st day of September, 2017;
  - (b) extended for a period of sixty days by virtue of the Law Reform (Zones of Special Operations) (Special Security and Community Development Measures) (The Mount Salem Community and Environs in the Parish of Saint James Zone) Extension of Period of Operation Order, 2017;
  - (c) extended for a further period of sixty days by virtue of the Law Reform (Zones of Special Operations) (Special Security and Community Development Measures) (The Mount Salem Community and Environs in the Parish of Saint James Zone) Extension of Period of Operation (No. 2) Order, 2017;
  - (d) extended for a further period of sixty days by virtue of the Law Reform (Zones of Special Operations) (Special Security and Community Development Measures) (The Mount Salem Community and Environs in the Parish of Saint James Zone) Extension of period of Operation Order, 2018;

- (e) extended for a further period of sixty days by virtue of the Law Reform (Zones of Special Operations) (Special Security and Community Development Measures) (The Mount Salem Community and Environs in the Parish of Saint James Zone) Extension of period of Operation (No. 2) Order, 2018;
- (f) extended for a further period of sixty days by virtue of the Law Reform (Zones of Special Operations) (Special Security and Community Development Measures) (The Mount Salem and Environs in the Parish of Saint James Zone) Extension of Period of Operation (No. 3) Order, 2018; and
- (g) extended for a further period of sixty days by virtue of the Law Reform (Zones of Special Operations) (Special Security and Community Development Measures) (The Mount Salem and Environs in the Parish of Saint James Zone) Extension of period of Operation (No. 4) Order, 2018, is hereby extended for a further period of sixty days from the end of the period referred to in paragraph (g).
