THE LAW REVISION ACT

THE LAW REVISION (AUTHORIZED PAGES) (SUBSIDIARY LEGISLATION)
ORDER, 2019

In exercise of the power conferred upon the Minister by section 6 of the Law Revision Act, the following Order is hereby made:—

1. This Order may be cited as the Law Revision (Authorized Pages) (Subsidiary Legislation) Order, 2019.
2. In this Order “relevant subsidiary legislation pages” means the pages concerning subsidiary legislation approved by the Commissioners for insertion in the Revised Laws bearing thereon reference to the authorization given by this Order.

3. As regards the subjects specified in the first column of the Schedule—
- (a) the pages specified in relation thereto respectively in the second column of the Schedule are hereby authorized to be removed from the Revised Laws as from the 31st day of October, 2019;
 - (b) the relevant subsidiary legislation pages specified in relation thereto respectively in the third column of the Schedule are hereby authorized to be included in the Revised Laws as from the 31st day of October, 2019.
