THE LAW REVISION ACT

THE LAW REVISION (AUTHORIZED PAGES) ORDER, 2019

In exercise of the power conferred upon the Minister by section 6 of the Law Revision Act, the following Order is hereby made:—

1. This Order may be cited as the Law Revision (Authorized Pages) Order, 2019.
2. As regards the Acts specified in the first column of the First Schedule—
 - (a) the pages specified in relation thereto respectively in the second column of the Schedule are hereby authorized to be removed from the Revised Laws as from the 30th day of June, 2019;
 - (b) the new pages specified in relation thereto respectively in the third column of the Schedule are hereby authorized to be included in the Revised Laws as from the 30th day of June, 2019.

3. In relation to the Chronological Table to the Revised Laws referred to in the first column of the Second Schedule—

- (a) the pages specified in the second column of the Schedule are hereby authorized to be removed from the Revised Laws as from the 30th day of June, 2019;
- (b) the new pages specified in the third column of the Schedule are hereby authorized to be included in the Revised Laws as from the 30th day of June, 2019.
