**THE LOCAL GOVERNANCE (MUNICIPALITY OF PORTMORE)
(CHANGE OF NAME) ORDER, RESOLUTION, 2018**

WHEREAS, section 5(3)(a) of the Local Governance Act (hereinafter referred to as "the Act") continued the Municipality of Portmore as a City Municipality under the Act;

AND WHEREAS section 5(3)(b) of the Act provides that this City Municipality is to be known as the Municipality of Portmore, unless otherwise determined by the Minister by order subject to affirmative resolution;

AND WHEREAS on the 9th day of February, 2018, the Minister made the Local Governance (Municipality of Portmore) (Change of Name) Order, 2018:

NOW, THEREFORE, BE IT RESOLVED by this Honourable House as follows:

- (i) This Resolution may be cited as the Local Governance (Municipality of Portmore)(Change of Name) Order, Resolution, 2018;
- (ii) The Local Governance (Municipality of Portmore) (Change of Name) Order, Resolution, 2018, which was laid on the Table of the House on the 28th day of February, 2018, is hereby affirmed.

(CHANGE OF NAME) ORDER, 2018**

1. This Order may be cited as the Local Governance (Municipality of Portmore) (Change of Name) Order, 2018.
2. The Municipality of Portmore is to be known as the Portmore City Municipality.
