Honourable Senator Kamina Johnson Smith, Minister of Foreign Affairs and Foreign Trade and Leader of Government Business, moved:

**THE LOCAL GOVERNANCE ACT**

**THE LOCAL GOVERNANCE (MUNICIPALITY OF PORTMORE)  
(CHANGE OF NAME) ORDER, RESOLUTION, 2018**

WHEREAS section 5(3)(a) of the *Local Governance Act* (hereinafter referred to as "the Act") continued the Municipality of Portmore as a City Municipality under the Act;

AND WHEREAS section 5(3)(b) of the Act provides that this City Municipality is to be known as the Municipality of Portmore, unless otherwise determined by the Minister by order subject to affirmative resolution;

AND WHEREAS on the 9th day of February, 2018, the Minister made the Local Governance (Municipality of Portmore) (Change of Name) Order, 2018:

NOW, THEREFORE, BE IT RESOLVED by this Honourable Senate as follows:—

- (a) This Resolution may be cited as the Local Governance (Municipality of Portmore) (Change of Name) Order, Resolution, 2018;
- (b) The Local Governance (Municipality of Portmore) (Change of Name) Order, 2018, which was laid on the Table of the Senate on the 8th day of June, 2018, is hereby affirmed.

Senator Wensworth Skeffery, Senator Delroy Williams, Senator Sophia Frazer-Binns and Senator Lambert Brown also spoke on the resolution.

### THE LOCAL GOVERNANCE ACT

#### THE LOCAL GOVERNANCE (MUNICIPALITY OF PORTMORE) (CHANGE OF NAME) ORDER, 2018

In exercise of the power conferred upon the Minister by section 5(3)(b) of the Local Governance Act, and every other power hereunto enabling, the following Order is made, subject to affirmative resolution:—

1. This Order may be cited as the Local Governance (Municipality of Portmore) (Change of Name) Order, 2018.
2. The Municipality of Portmore is to be known as the Portmore City Municipality.
