**THE PASSPORT ACT**

The Minister in exercise of the power conferred upon him by section 7 of the Passport Act hereby authorizes:—

Mr. Dmitry Robertson (First Secretary) in the Permanent Mission of Jamaica in Geneva, with jurisdiction over Switzerland, Republic of Austria, the Hellenic Republic (Greece), Republic of Italy and Republic of Turkey to exercise all of the functions that the Minister is authorized by that Act to exercise in Jamaica.

PROVIDED, HOWEVER, that the power to refuse the issue of, or to cancel a passport or an emergency certificate or other travel document issued by the Minister, shall not be exercised without prior approval of the Minister.
