THE PHARMACY ACT

THE PHARMACY (AMENDMENT) (REGULATIONS), 2021

In exercise of the power conferred upon the Council by section 25 of the Pharmacy Act, and of every other power hereunto enabling, the following Regulations are hereby made:—

1. These Regulations may be cited as the Pharmacy (Amendment) Regulations, 2021, and shall be read and construed as one with the Pharmacy Regulations, 1975 (hereinafter referred to as the “principal Regulations”) and all amendments thereto.
2. Regulation 4 of the principal Regulations is amended—
 - (a) in paragraph (4) by deleting the words “five thousand dollars” wherever they appear and substituting therefor, in each case, the words “six thousand five hundred dollars”.

- (b) in paragraph (5B) by deleting the words "Form H" and substituting therefor the words "Form C1".
3. Regulation 4A of the principal Regulations is amended in paragraph (4) by deleting the words "Form C1-" and substituting therefor the words "Form H".
4. Regulation 5 of the principal Regulations is amended—
- (a) by deleting paragraph (3) and substituting therefor the following—
- “ (3) There shall be paid, by an applicant, in respect of every registration (or renewal thereof) of a shop—
- (a) as a commercial or retail pharmacy, a fee of ten thousand dollars;
- (b) as a manufacturing pharmacy, a fee of fifteen thousand dollars;
- (c) as a distribution or wholesale pharmacy, a fee of forty thousand dollars;
- (d) as a professional pharmacy, a fee of eight thousand dollars, upon the applicant being notified that his application has been successful”;
- (b) in paragraph (4) by deleting the words "two thousand five hundred dollars" and substituting therefor the words, "five thousand dollars”;
- (c) in paragraph (5) by deleting the words "fifteen thousand dollars" and substituting therefor the words "twenty thousand dollars”;
- (d) in subparagraph (6)(b) by deleting the words "five hundred dollars" and substituting therefor the words "two thousand five hundred dollars”.
5. Regulation 20 of the principal Regulations is amended in paragraph (4) by deleting the words "thirty-six hours" and substituting therefor the words "one hundred and twenty hours”.
6. Regulation 26 of the principal Regulations is amended—
- (a) in paragraph (4) by deleting the words "two thousand five hundred" and substituting therefor the words "five thousand dollars.”;
- (b) in paragraph (5) by deleting the words "five hundred dollars" and substituting therefor the words "two thousand five hundred dollars”.

7. The First Schedule to the principal Regulations is amended, in Form C1 by deleting from the first column the words "Registration Fee 5,000.00" and substituting therefor the words "Registration Fee \$6,500.00".
