THE PENSIONS (PUBLIC SERVICE) (DETERMINATION OF PENSIONABLE OFFICES) (SPECIFIED DATE) ORDER, 2018

In exercise of the power conferred upon the Minister by sections 2(1) and 3(1) of the Pensions (Public Service) Act, the following Order is hereby made:—

- 1. This Order may be cited as the Pensions (Public Service) (Determination of Pensionable Offices) (Specified Date) Order, 2018.
- 2. The Minister hereby determines April 1, 2018, to be the date for the purposes of the definition of "existing public officer".
- 3. The Minister hereby determines the period commencing April 1, 2018, to be the date for the purposes of the definition of "new public officer".

4. The Minister hereby determines the period commencing April 1, 2018, and ending of March 31, 2023, to be the period for the purposes of the definition of "transition period".

- 2. The Minister hereby determines April 1, 2018, to be the date for the purposes of section 6(2) of the Act.

THE PENSIONS (PUBLIC SERVICE) ACT

THE PENSIONS (PUBLIC SERVICE) (PENSIONS CONTRIBUTIONS PRESCRIBED AMOUNT)
(SPECIFIED DATE) ORDER, 2018

In exercise of the power conferred upon the Minister by sections 6(2) and 11(1) and (2) of the Pensions (Public Service) Act, the following Order is hereby made:—

1. This Order may be cited as the Pensions (Public Service) (Pensions Contributions Prescribed Amount) (Specified Date) Order, 2018.

- 2. As of April 1, 2018, the amounts specified in paragraph 3 shall be deducted from the salary or part salary of a pensionable officer and an officer employed in a pensionable office and paid into the Consolidated Fund pursuant to section 6(2) of the Act, as a contribution towards the pensions, gratuities and other allowances provided for under the Act.
- 3. Pursuant to paragraph 2, commencing from April 1, 2018, the contributions shall be deducted as follows for members of the Public Service Pension Scheme—
 - (a) with effect from April 1, 2018 an amount of 1 %;
 - (b) with effect from April 1, 2019 an amount of 2%;
 - (c) with effect from April 1, 2020 an amount of 3%;
 - (d) with effect from April 1, 2021 an amount of 4%; and
 - (e) with effect from April 1, 2022 and onwards an amount of 5%.
