**JUDICIAL NOTICE**

By Order of the Chief Justice with the concurrence of the Puisne Judges of the Supreme Court, the following Practice Direction is hereby issued.

This Direction supercedes the directions dated the 15th April, 1941 and 24th April, 1975.

For the purpose of convenience the business of the Court has been divided into the following divisions:—

Bankruptcy, Civil, Commercial, Family and Probate.

With immediate effect all matters which were formally filed in Attorney-at-Law, Common Law, Admiralty, Equity, E.R.C., and Miscellaneous will now be filed in the Civil Division.

Cases will now be numbered without reference to the initial letter of the Claimant's or Petitioner's name.

They will be designated as follows:—

CIVIL DIVISION  
Claim No. HCV 1 of 2003

COMMERCIAL DIVISION  
Claim No. C.D. 1 of 2003

FAMILY DIVISION  
Claim No. F.D. 1 of 2003

Claim No. P.D. 1 of 2003

### PRACTICE DIRECTION

By Order of the Chief Justice and with the concurrence of the Puisne Judges of the Supreme Court, the following Practice Direction is hereby issued to take effect from the 31st day of January, 2003.

In all civil proceedings in the Supreme Court, whether the Civil Procedure Rules, 2002 ("CPR") apply to those proceedings or not:

- (1) All documents filed in the Registry of the Supreme Court must comply with the provisions of Rule 3.6(1) of the Civil Procedure Rules, 2002;
- (2) All Affidavits must comply with the provisions of Rule 30.2 of the Civil Procedure Rules, 2002.

**PRACTICE DIRECTION**

By Order of the Chief Justice and with the concurrence of the Puisne Judges of the Supreme Court, the following Practice Direction is hereby issued to take effect from the 31st day of January, 2003.
