THE PUBLIC CEMETERY MANAGEMENT AND REGULATION ACT

THE PUBLIC CEMETERY MANAGEMENT AND REGULATION (ST. CATHERINE) (AMENDMENT) RULES, 2018

In exercise of the power conferred upon the Council by section 9 of the Public Cemetery Management and Regulation Act, the following Rules are made, having notified the Minister by memorandum in writing in accordance with section 51(6) of the *Local Governance Act*—

1. These Rules may be cited as the Public Cemetery Management and Regulation (St. Catherine) (Amendment) Rules, 2018, and shall be read and construed as one with the Public Cemetery Management and Regulation (St. Catherine) Rules, 1992 (hereinafter referred to as the "principal Rules") and all amendments thereto.

2. The principal Rules are amended by inserting next after rule 12, the following as rule 12A—

"Fees payable 12A. The fees payable under-

under Parts

II and III of Schedule.

- (a) Part II of the Schedule shall apply to cemeteries established before the 31st day of August 2017;
- (b) Part III of the Schedule shall apply to cemeteries established on or after the 31st day of August 2017.".
- 3. Rule 13 of the principal Rules is amended by deleting the words "Part II" and substituting therefor the words "Parts II and III".
- 4. Rule 15 of the principal Rules is amended in subrule (9) by deleting the words "Part II" and substituting therefor the words "Parts II and III".
- 5. Rule 24 of the principal Rules is amended in subrule (1) by deleting the words "Part II" and substituting therefor the words "Parts II and III".
- 6. The principal Rules are amended by deleting the Schedule and substituting therefor the following as the Schedule—
