THE REGISTRATION OF TITLES, CADASTRAL MAPPING AND TENURE CLARIFICATION (SPECIAL PROVISIONS) ACT, TEL AVIV, SOUTHSIDE AND ROSE GARDENS. KINGSTON (SOUTH CENTRAL) PROJECT AREA ORDER, 2019

In exercise of the powers conferred upon the Minister by section 3 of the Registration of Titles, Cadastral Mapping and Tenure Clarification (Special Provisions) Act, the following Order is hereby made:—

- 1. This Order may be cited as the Registration of Titles, Cadastral Mapping and Tenure Clarification (Special Provisions) (Tel Aviv, Southside and Rose Gardens, Kingston (South Central) Project Area) Order, 2019.
- 2. The area set out in Part I of the Schedule, which is delineated on the map set out in Part II of the Schedule, is hereby declared to be a project area for the purposes of section 3 of the Act and shall be known as Tel Aviv, Southside and Rose Gardens, Kingston (South Central) Project Area.

FIRST SCHEDULE


TECHNICAL DESCRIPTION

PART I

Tel Aviv, Southside and Rose Gardens, Kingston (South Central) for Declaration by the Honourable Minister

Commencing at 'A', the junction of Duke Street and Port Royal Street; thence northerly along Duke Street to its intersection with Beeston Street; thence easterly along Beeston Street to its intersection with Text Lane; thence northerly along Text Lane to its intersection with North Street; thence generally south-easterly along North Street to its intersection with South Camp Road; thence south-westerly along South Camp Road to its intersection with East Queen Street and Victoria Avenue; thence easterly along Victoria Avenue to its intersection with Paradise Street; thence southerly along Paradise Street, crossing Michael Manley Boulevard, to the Kingston Harbour shore line; thence south-westerly and generally westerly along this shore line to meet the southern boundary of the aforementioned road; thence continuing westerly along the southern boundary of this said road to Port Royal Street; thence continuing generally westerly along Port Royal Street back to the starting point 'A'.
