CLARIFICATION (SPECIAL PROVISIONS) (SECTION 5—PART OF SKIDAW
IN THE PARISH OF ST. ELIZABETH) ORDER, No. 0140/2022

In exercise of the power conferred upon the Minister by section 5 of the Registration of Titles, Cadastral Mapping and Tenure Clarification (Special Provisions) Act, 2005, the following Order is hereby made:—

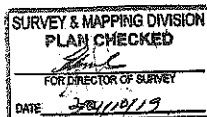
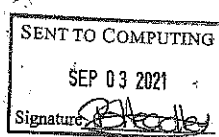
1. This Order shall be cited as the Registration of Titles, Cadastral Mapping and Tenure Clarification (Special Provisions) (Section 5—Part of Skidaw in the parish of St. Elizabeth) Order, No. 0140/2022.

An application is to be made to the Office of Titles at the National Land Agency to have the applicant become the registered proprietor of the portions of land to be transferred. 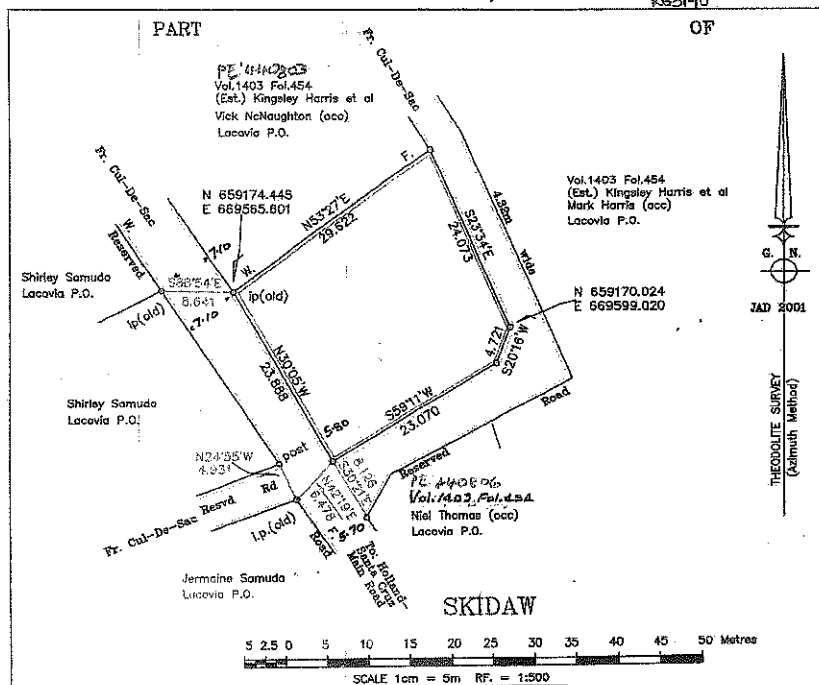
Plan of land part of Skidaw in the parish of St. Elizabeth as set out in the table at Part I above.
