In exercise of the power conferred upon the Minister by Regulations 33(1) and 38 of the Emergency Powers Regulations, 2019, the following Order is hereby made:—

1. This Order may be cited as the Detention (Devon Blair o/c Avatar) (State of Public Emergency for the Parishes of Clarendon and St. Catherine) Order, 2019.
2. Devon Blair o/c Avatar, is to be detained from June 15, 2020 until the end of the period of the public emergency which commenced with the Proclamation of the Governor-General published in the Jamaica Gazette Supplement Proclamation, Rules and Regulations of 2019.

3. For the purposes of paragraph 11 of regulation 38, notice is hereby given as follows:

- a. Devon Blair o/c Avatar, has been concerned in acts prejudicial to public safety and public order, more specifically:
 - i. Suspected of being the leader of a criminal organization namely, the Bucks Common Gang operating in the Bucks Common District, May Pen, Clarendon and involved in shootings and robberies related to gang activities; and
 - ii. Suspected of being in possession of illegal firearms.
- b. Section 13(10) of the Constitution of Jamaica gives you the right to request a review of your case at any time during the period of your detention which is to be reviewed by The Emergency Powers Tribunal and Regulation 38(6) of the Emergency Powers Regulations, 2019 gives you the right to make objection against the Detention Order to The Emergency Powers Review Tribunal.

DETENTION (DONNATH LAMEY O/C ROBOT) (STATE OF PUBLIC EMERGENCY FOR THE PARISHES OF ST. JAMES, HANOVER AND WESTMORELAND) ORDER, 2019

In exercise of the power conferred upon the Minister by regulations 33(1) and 38 of the Emergency Powers Regulations, 2019, the following Order is hereby made:—

1. This Order may be cited as the Detention Donnath Lamey o/c Robot (State of Public Emergency for the Parishes of St. James, Hanover and Westmoreland) Order, 2019.

2. Detention Donnath Lamey o/c Robot, is to be detained from June 5, 2020 until the end of the period of the public emergency which commenced with the Proclamation of the Governor-General published in the Jamaica Gazette Supplement Proclamation, Rules and Regulations on the 7th day of May, 2019.

3. For the purposes of paragraph 11 of regulation 38, notice is hereby given as follows:

- a. Donnath Lamey o/c Robot, has been concerned in acts prejudicial to public safety and public order, more specifically:
 - i. Suspected of being a member of a criminal organization operating in the Roaring River community in the Parish of Westmoreland and of being involved in the extortion of lottery scammers and operators of small businesses related to gang activities;
 - ii. Suspected of being involved in the murder of Kashwayne Bennett o/c Lasso committed on March 23, 2020 in the Roaring River community, Petersfield, Westmoreland;
 - iii. Suspected of being in possession of an illegal firearm.
- b. Section 13(10) of the Constitution of Jamaica gives you the right to request a review of your case at any time during the period of your detention which is to be reviewed by The Emergency Powers Tribunal and Regulation 38(6) of the Emergency Powers Regulations, 2019 gives you the right to make objection against the Detention Order to The Emergency Powers Review Tribunal.

In exercise of the power conferred upon the Minister by regulations 33(1) and 38 of the Emergency Powers Regulations, 2019, the following Order is hereby made:—

1. This Order may be cited as the Detention Kino Samuels o/c Kino (State of Public Emergency for the Parishes of St. James, Hanover and Westmoreland) Order, 2019.

2. Kino Samuels o/c Kino, is to be detained from June 2, 2020 until the end of the period of the public emergency which commenced with the Proclamation of the Governor-General published in the Jamaica Gazette Supplement Proclamation, Rules and Regulations on the 7th day of May, 2019.

3. For the purposes of paragraph 11 of regulation 38, notice is hereby given as follows:

- a. Kino Samuels o/c Kino, has been concerned in acts prejudicial to public safety and public order, more specifically:
 - i. Suspected of being a member of a criminal organization-the Dalling Street Gang- operating in the Dalling Street community, sections of the Hudson Street community and sections of the Barracks Road community in Savanna-la-Mar, Westmoreland;
 - ii. Suspected of being involved in lottery scamming and of being in illegal possession of firearms in the Dalling Street community;
 - iii. Suspected of shooting and wounding Mr. Everton Silent on October 12, 2019, at Seaton Crescent Street, Savanna-la-Mar, Westmoreland. Mr. Samuels was arrested and charged for the offences Wounding with Intent and Illegal Possession of Firearm in relation to this matter. These charges are currently before the court; and
 - iv. Suspected of being involved in the murder of Mr. Kashwayne Bennett o/c Lasso committed on March 23, 2020 in the Roaring River community, Petersfield, Westmoreland.
- b. Section 13(10) of the Constitution of Jamaica gives you the right to request a review of your case at any time during the period of your detention which is to be reviewed by The Emergency Powers Tribunal and Regulation 38(6) of the Emergency Powers Regulations, 2019 gives you the right to make objection against the Detention Order to The Emergency Powers Review Tribunal.
