THE ROAD TRAFFIC ACT

THE ROAD TRAFFIC (AMENDMENT) (No. 2) REGULATIONS, 2019

In exercise of the power conferred upon the Minister by section 59 of the Road Traffic Act, and of every other power hereunto enabling, the following Regulations are hereby made:—

- 1. These Regulations may be cited as the Road Traffic (Amendment) (No. 2) Regulations, 2019, and shall be read and construed as one with the Road Traffic Regulations, 1938 (hereinafter referred to as the "principal Regulations") and all amendments thereto, and shall come into operation on the 25th day of January, 2020.
 - 2. Paragraph (3) of regulation 45 of the principal Regulations is amended
 - a) by deleting the words "application of two recent photographs of the applicant one of which shall be attached to the Provisional Driver's Licence granted to the applicant and the other" and substituting therefor the words "application, in the form set out as Form "H3A" in the First Schedule, of three recent photographs of the applicant, one of which shall be attached to the Provisional Driver's

- Licence granted to the applicant, one retained by the Licensing Authority and the other";
- (b) in subparagraph (c) by deleting the full-stop at the end of the sub-paragraph and substituting therefor a semi-colon; and
- (c) by inserting next after subparagraph (c) as amended, the following—
 - "(d) the applicant shall satisfy, by test, a Certifying Officer of the Licensing Authority, that he is conversant with the Road Code; and
 - (e) the applicant shall provide the Licensing Authority with proof of his age by furnishing the Licensing Authority with a certified copy of his birth certificate or a valid Government issued identification.".
- 3. The principal Regulations are amended by inserting next after paragraph (3) of regulation 45, as amended, the following—
 - " (3A) A Provisional Driver's Licence is renewable twelve months from the date of its issue, upon an application under paragraph (3).
 - (3B) A person who was granted a Provisional Driver's Licence after the commencement of these Regulations, and subsequently applies for the renewal of the Provisional Driver's Licence, shall not be required to satisfy the condition under subparagraph (3)(d) for the renewal of such Provisional Driver's Licence.
- 4. The First Schedule to the principal Regulations is amended by inserting next after "Form H3" the form set out as "Form H3 A" in the Schedule to these Regulations.
