## THE SPECIAL ECONOMIC ZONES ACT

THE SPECIAL ECONOMIC ZONE (ACCENT MARKETING JAMAICA LIMITED—PART NUMBERS 63–67 KNUTSFORD BOULEVARD, KINGSTON 5) ORDER, 2019

In exercise of the powers conferred upon the Minister by section 18(1) (Designation of Special Economic Zone), section 22 (Minister's approval required), section 27 (Duration of master-concession and licence agreement) and section 53 (Tax incentives applicable to former Free Zones) of the Special Economic Zones Act, 2016, the following Order is hereby made:—

- 1. This Order may be cited as the Special Economic Zone (Accent Marketing Jamaica Limited -Part Numbers 63-67 Knutsford Boulevard, Kingston 5) Order, 2019.
- 2. The third, fourth and fifth floors of the multi-storey building erected on lands now known as Numbers Sixty-Three, Sixty-Five and Sixty-Seven Knutsford Boulevard in the parish of Saint Andrew and which said floors now represent Strata Lots 13, 14 and 15 of Strata Plan Number 707 and are registered respectively at Volume 1307 Folio 959, Volume 1307 Folio 960 and Volume 1307 Folio 961, which together comprise in total 1842 square

metres (19,654 square feet) and commencing at the south western corner, thence north easterly for a distance of 30.6 metres to another corner, thence south easterly for a distance of 7.3 metres to another corner, then north easterly for a distance of 2.1 metres to another corner, thence south easterly for a distance of 14.3 metres to another corner, thence south westerly for a distance of 2.5 metres to another corner, thence south easterly for a distance of 7.2 metres to another corner, thence south westerly for a distance of 21.5 metres to another corner, thence north westerly for a distance of 7.0 metres to another corner, thence south westerly for a distance of 14.3 metres to another corner, thence north westerly for a distance of 1.9 metres to another corner, thence north westerly for a distance of 1.9 metres to another corner, thence north westerly for a distance of 1.9 metres to another corner, thence north westerly for a distance of 1.9 metres

- 3. The Special Economic Zone to be a Single Entity Developer and may be referred to as Accent Marketing Jamaica Limited.
- 4. The Special Economic Zone Authority to enter into a Licence Agreement with Accent Marketing Jamaica Limited.
