THE SPECIAL ECONOMIC ZONES ACT

THE SPECIAL ECONOMIC ZONE (CRL SEZ LIMITED—PART OF TORBAY RECLAIMED LANDS AND THE BOGUE ESTATE NOW CALLED MONTEGO FREEPORT IN THE PARISH OF SAINT JAMES BEING LOTS NUMBERED H THIRTY-EIGHT AND H THIRTY-EIGHT A.) ORDER, 2019

In exercise of the powers conferred upon the Minister by section 18(1) (Designation of Special Economic Zone) and section 22 (Minister's approval required) and section 27 (Duration of Master Concession and Licence Agreement) of the Special Economic Zones Act, 2016, the following Order is hereby made:—

- 1. This Order may be cited as the Special Economic Zone (CRL SEZ Limited—Part of Torbay Reclaimed Lands and the Bogue Estate now called Montego Freeport in the parish of Saint James being Lots numbered H Thirty-Eight and H Thirty-Eight A.) Order, 2019.
- 2. All that parcel of land situated in the parish of Saint James known on the plan as parts of Torbay Reclaimed Lands and The Bogue Estate now called Montego Freeport being numbered Lots H38 and H38A on the plan of Montego Freeport deposited in the office of

Titles on the 3rd July 1970 and registered at Volume 1181 Folio 575 of the Register Book of Titles together with lands part of Bogue Estate registered in office of Title on the 6th February 1987 and registered at Volume 1203 Folio 904 of the Register Book of Titles.

Commencing at the common corner of lands in the parish of Saint James known as Montego Freeport registered at Volume 1181 Folio 575 of the Register Book of Titles and the northern-eastern boundary of Pimento Way and south-eastern corner of lands registered at Volume 1203 Folio 904 of the Registered Book of Titles to a point 40 feet in a westerly direction, then 383.86 feet northerly, then 356.75 feet easterly, then 195.77 feet south-easterly, then 286.33 ft. southerly, then 479.46 feet westerly to the common corner starting point.

- 3. The Special Economic Zone to be referred to as CRL SEZ Limited.
- 4. The Special Economic Zone Authority to enter into a Licence Agreement with CRL SEZ Limited.
