SPECIAL ECONOMIC ZONES ACT

THE SPECIAL ECONOMIC ZONE (CONDUENT SOLUTIONS (JAMAICA) LIMITED — PART OF BELMONT KNOWN AS NUMBERS 5A and 7 RAINING ROAD IN THE PARISH OF SAINT ANDREW) ORDER, 2019

In exercise of the powers conferred upon the Minister by section 18(1) (Designation of Special Economic Zone), section 22 (Minister's approval required), section 27 (Duration of master-concession and licence agreement) and section 53 (Tax incentives applicable to former Free Zones) of the Special Economic Zones Act, 2016, the following Order is hereby made:—

- 1. This Order may be cited as the Special Economic Zone (Conduent Solutions (Jamaica) Limited Part of Belmont Known as Numbers 5A and 7 Haining Road in the parish of Saint Andrew) Order, 2019.
- 2. Property comprises ground and first floor of main building, part of Belmont known as numbers five and seven Haining Road in the parish of Saint Andrew registered at Volume 1447 Folio 344 and comprising in total area one thousand and ninety-one point four one

square metres and commencing at the north-eastern corner of the ground floor, thence south-west for a distance of twelve point six nine metres to another corner, thence north-west for a distance of eleven point four one metres to another corner, thence north-west for a distance of three point eight eight metres to another corner, thence north-west for a distance of seventeen point one four metres to another corner, thence north-east for a distance of four point two one metres to another corner, thence south-east for a distance of eleven point six two metres to another corner, thence north-east for a distance of one point five four metres to another corner, thence north-east for a distance of one point five four metres to another corner, thence south-east for a distance of twenty-six point six two metres to the starting point and comprising an area of four hundred and twenty point five eight square metres.

Commencing at the north-eastern comer of the first floor, thence south-west for a distance of twelve point six nine metres to another corner, thence north-west for a distance of eleven point four one metres to another corner, thence south-west for a distance of four point one nine metres to another corner, thence south-east for a distance of eight point four four metres to another corner, thence south-west for a distance of one point one zero metres to another corner, thence south-east for a distance of four point six eight metres to another corner, thence south-west for a distance of four point six seven metres to another corner, thence south-west for a distance of one point seven eight metres to another corner, thence north-west for a distance of twenty seven point five eight metres to another corner, thence north-east for a distance of ten point one zero metres to another corner, thence south-east for a distance of one point nine seven metres to another corner, thence north-east for a distance of three point eight three metres to another corner, thence south-east for a distance of two point eight three metres to another corner, thence north-east for a distance of twelve point three six metres to another corner thence south-east for a distance of twenty-five point six five metres to the starting point and comprising an area of six hundred and seventy point six three square metres.

Total area of ground and first floor is one thousand and ninety-one point four one square metres

- 3. The Special Economic Zone to be designated a Single Entity Zone and may be referred to as Conduent Solutions (Jamaica) Limited.
- 4. The Special Economic Zone Authority to enter into a Licence Agreement with Conduent Solutions (Jamaica) Limited.
