THE SPECIAL ECONOMIC ZONES ACT

THE SPECIAL ECONOMIC ZONE (CR8SPACE LIMITED—STRATA LOT 4, PART OF
LAND KNOWN AS NOS. 69, 73 AND 75 CONSTANT SPRING ROAD,
SAINT ANDREW) ORDER, 2019

In exercise of the powers conferred upon the Minister by section 17 (Restriction on Single-Entity Zones), section 18(1) (Designation of Special Economic Zone) and section 22 (Minister's approval required) of the Special Economic Zones Act, 2016, the following Order is hereby made:—

1. This Order may be cited as the Special Economic Zone (Cr8Space Limited-Strata Lot 4, Part of land known as Nos. 69, 73 and 75 Constant Spring Road, Saint Andrew) Order, 2019.
2. All that parcel of land known as strata lot 4 part of land known as Nos. 69, 73 and 75 Constant Spring Road, in the parish of Saint Andrew and being lands registered at Volume 1239 Folio 502 of the Register Book of Titles, beginning on the ground floor at the common boundary of lots 4 and 5 (Volume 1239 Folio 503) at a concrete partition wall, being the most

north-easterly corner and moving in a southerly direction along the said concrete wall for approximately 20m, butting and bounding to the east by the common boundary lots of 4 and 5, to the most south-easterly point of the concrete partition wall; then in a westerly direction along a concrete building for approximately 11.5m, butting and bounding to the south by the common area of the strata development, to the most south-westerly point at the common boundary of lots 3 (Volume 1239 Folio 501) and 4 at a concrete partition wall; then in a northerly direction along a concrete partition wall for approximately 20 m, butting and bounding to the west by the common boundary of lots 3 and 4, to the most north-westerly point; then in an easterly direction along a concrete building wall for approximately 11.5m, butting and bounding to the north by the common area of the strata development to the point of commencement or however such lands may be bounded or butted by and containing by survey 228.73 square meters.

3. The Special Economic Zone to be a Single Entity Zone and may be referred to as Cr8Space Limited.

4. The Special Economic Zone Authority to enter into a Licence Agreement not to exceed September 30, 2028 with Cr8Space Limited.
