**THE SPECIAL ECONOMIC ZONES ACT**

THE SPECIAL ECONOMIC ZONES (DESIGNATION OF BETAINE (JAMAICA)  
LIMITED WORTHINGTON SPECIAL ECONOMIC ZONE) ORDER, 2021

In exercise of the powers conferred upon the Minister by sections 18(1) and 22 of the Special Economic Zones Act, 2016, and every other power hereunto enabling, the following Order is hereby made:—

1. This Order may be cited as the Special Economic Zones (Designation of Betaine (Jamaica) Limited Worthington Special Economic Zone) Order, 2021.
2. On the recommendation of the Special Economic Zone Authority, having regard to the matters set out in section 17(2) of the Act, and after consultation with the Minister responsible for finance, the geographical area described in the Schedule shall be designated as a Special Economic Zone, and shall be referred to as the Betaine (Jamaica) Limited Worthington Special Economic Zone.

3. Entry by the Special Economic Zone Authority into a licence-agreement with Betaine (Jamaica) Limited is approved.

## Betaine (Jamaica) Limited Worthington Special Economic Zone

*Description of Geographical Area*

The geographical area designated as the Betaine (Jamaica) Limited Worthington Special Economic Zone (hereinafter referred to as the property) is described as follows—

The Property is part of Number 11 Trafalgar Road part of Worthington in the parish of Saint Andrew, registered at Volume 1043 Folio 605 in the Register Book of Titles, with the civic address being Number 14 Worthington Terrace, formerly part of Number 11 Trafalgar Road in the parish of Saint Andrew, registered at Volume 1241 Folio 339 in the Register Book of Titles, with the civic address being Number 12 to 14 Worthington Terrace, Kingston 5.

The property is located on the north-eastern side of Worthington Terrace, seventy metres and four tenth of a metre (70.4m) south-east of the intersection of Worthington Avenue and Worthington Terrace.

The property is bound:

North-westerly , partly by number 16 Worthington Terrace and partly by number 11 Trafalgar Road.

North-easterly, by number 9 Trafalgar Road.

South-easterly, partly by Number 7 Trafalgar Road and partly by number 10 Worthington Terrace.

South-westerly, by Worthington Terrace.

The north-eastern boundary is sixty-four metres and sixty-eight hundredths of a metre long (64.68m).

The north-eastern boundary is thirty-three metres and ninety-eight hundredths of a metre long (33.98m).

The south-eastern boundary is sixty-three metres and nineteen hundredths of a metre long (63.19m).

The south-western boundary is thirty-four metres and fifteen hundredths of a metre long (34.15m).

The area of the property is 2,220 square metres.
