The following supersedes the publication appearing in the Jamaica Gazette Proclamations, Rules and Regulations on July 4, 2019:

THE SPECIAL ECONOMIC ZONES ACT

THE SPECIAL ECONOMIC ZONE (JAMAICA RED MOON LIMITED)
EXPANSION ORDER, 2019

In exercise of the powers conferred upon the Minister by section 18(1) (Designation of Special Economic Zone) and section 22 (Minister's approval required) of the Special Economic Zones Act, 2016, the Special Economic Zone (Jamaica Red Moon) Order, 2017 was published in the Jamaica Gazette Supplement, Vol. CXL No. 87D, issued on December 14, 2017. Pursuant to the Special Economic Zones Act and Regulation 28 of the Special Economic Zones Regulations, 2017 the following Order is hereby made:—

1. This Order may be cited as the Special Economic Zone (Jamaica Red Moon Limited) Expansion Order, 2019.

- 2. Commencing at the most southerly point of the boundary of lands hereinafter described, the said point being that which is at the intersection of the main road leading from Chapelton to Rock River and the subject property abovementioned as registered at Volume 1085 Folio 283, proceed north-easterly for a distance of two hundred and eight metres (208m) to a Utility pole along the same main road, directly opposite an old concrete building. Then continue further north-easterly for a distance of eighty-one metres (81m) to the intersection of the subject property boundary and the remainder of same lands registered as described herein. Proceed in a south-easterly direction along an internal boundary of the subject property for a distance of one hundred and fifty-eight metres (158m) to the point of intersection with the subject property and the same lands registered at Volume 1085 Folio 283; then continuing in a south-westerly direction for a distance of two hundred and seventy-four metres (274m) to the point of beginning at the same main road aforementioned; inclusive of all buildings, drainage, troughs, barns, easements and utility contained therein; encompassing Thirty thousand nine hundred and fifty-eight square metres (30,958 sq. m or 7.65 Acres) of land.
- 3. The Special Economic Zone to be a Single Entity Zone and referred to as Jamaica Red Moon.
- 4. The Special Economic Zone Authority to amend the Licence Agreement entered into with Jamaica Red Moon Limited and for the said Licence Agreement not to exceed August 31, 2027.
- 5. This Order hereby revokes Gazette Supplement Volume CXLI No. 141, issued on December 18, 2018.
