THE SPECIAL ECONOMIC ZONES ACT

THE SPECIAL ECONOMIC ZONE (KCT SERVICES LIMITED—PART OF NEWPORT WEST IN THE PARISH OF SAINT ANDREW) ORDER, 2019

In exercise of the powers conferred upon the Minister by section 18(1) (Designation of Special Economic Zone), section 22 (Minister's approval required), section 27 (Duration of master-concession and licence agreement) and section 53 (Tax incentives applicable to former Free Zones) of the Special Economic Zones Act, 2016, the following Order is hereby made:—

- 1. This Order may be cited as the Special Economic Zone (KCT Service Limited—Part of Newport West in the parish of Saint Andrew) Order, 2019.
- 2. Part of Volume 1041 Folio 168 now known as Kingston Logistics Park starting at a point where the northern corner of the property intersects with the eastern boundary of fourteenth Avenue and proceeding south-easterly to the northern apex of the building for a distance sixteen metres and four seventy sixth thousandths of a metre then continuing south-easterly along the outer face of the building for a distance of ninety metres and six

- hundred and four thousands of a metre to the eastern corner of the building then continuing south-easterly for a distance of thirty-two metres and nine hundredth and seven thousands of a metre to the south-eastern boundary wall separating this property from lot 449B registered at volume 1041 folio 180 then south-westerly along that boundary wall for a distance of one hundred and eighty one metres and four hundredths and sixty five thousandths of a metre then westerly for a distance of ten metres and sixty four hundredths of a metre to the intersection with the northern boundary of first street then north-westerly along the northern boundary of first street for a distance of one hundred and twenty-four metres and seventy-one hundredths of a metre to the beginning of the splay at the intersection with Fourteenth Avenue for a distance of ten metres and sixty-nine hundredths of a metre then north-easterly along the boundary wall on the eastern boundary of Fourteenth Avenue for a distance of one hundred and eighty-one metres and one hundred and eighty-five thousandths of a metre to the starting point butting north-easterly on the remainder of same lands south-easterly on lot 449B volume 1041 folio 180, south-westerly on first street on north-westerly on Fourteenth Avenue or howsoever it may be butted, bounded or described containing by survey twenty-five thousand two hundred and twentyfive and six hundredth and five thousand of a square metres (two hundred and seventyone thousand two hundred and forty-three square feet.).
- 3. The Special Economic Zone to be a single entity developer and may be referred to as KCT Services Limited.
- 4. The Special Economic Zone Authority to enter into a Licence Agreement with KCT Services Limited.
