## THE SPECIAL ECONOMIC ZONE ACT

THE SPECIAL ECONOMIC ZONE (KINGSTON FREEZONE CO. LIMITED)
ORDER, 2018

In exercise of the powers conferred upon the Minister by section 18(1) (Designation of Special Economic Zone) and section 22 (Minister's approval required) of the Special Economic Zone Act, 2016, the following Order is hereby made:—

- 1. This Order may be cited as the Special Economic Zone (Kingston Free Zone Co. Limited) Order, 2018.
- 2. Starting at a point at the south eastern end of the property where the eastern boundary wall intersects with the chain link fence running along the southern boundary of Caracas Avenue, which separates the Kingston Free Zone property from the Kingston Container Terminal property and proceeding north-westerly along that chain-link fence for a distance of 157.247 metres to the intersection with the eastern side of Unido Boulevard, then along

the chain link fence separating Unido Boulevard from the Kingston Container Terminal property for a distance of 117.81 metres, then along the chain link, fence separating the southern boundary of the property from the Kingston Container Terminal property for a distance of 109.7 metres, then north westerly for a distance of 18.31 metres to the northern face of the utility building then along the face of the building for a distance of 3.73 metres to the chain link fence, then north-easterly for a distance of 3.79 metres, then north westerly for a distance of 10.955 metres, then westerly for a distance of 3.425 metres, then 30,489 to the western boundary wall, then along that wall for a distance of 249.62 metres, to a chain link fence, then along the chain link fence for a distance of 18.59 metres, then east-south easterly for a distance of 16.3 metres, then south-easterly for a distance of 206.67 metres to the parking lot, then south westerly for a distance of 45.57 metres, then south-easterly for a distance of 101.17 metres to the eastern boundary wall, then southerly along that wall for a distance of 123.71 metres to the starting point, bordering northerly on First Avenue, easterly on the remainder of Volume 1041 Folio 170 now occupied by APM Terminals (Jamaica) Limited, southerly on the remainder of Volume 1041 Folio 170 now occupied by APM Terminals (Jamaica) Limited and westerly on the old Portmore Causeway, containing by survey, seventy thousand, one hundred and eighty four square metres.

- 3. The Special Economic Zone to be referred to as Kingston Special Economic Zone.
- 4. The Special Economic Zone Authority to enter into a License Agreement not to exceed fifty years with Kingston Free Zone Co. Limited.
