THE SPECIAL ECONOMIC ZONES ACT

THE SPECIAL ECONOMIC ZONE (LANCO INDUSTRIES LIMITED—PART OF CHARLEMONT AND STERLING CASTLE) ORDER, 2019

In exercise of the powers conferred upon the Minister by section 18(1) (Designation of Special Economic Zone), section 22 (Minister's approval required) and section 27 (Duration of master-concession and licence agreement) of the Special Economic Zones Act, 2016, the following Order is hereby made:—

- 1. This Order may be cited as the Special Economic Zone (Lanco Industries Limited—Part of Charlemont and Sterling Castle) Order, 2019.
- 2. The designated area comprises of buildings together with all its appurtenances measuring 371.75m² and 728.40 m² respectively, on that parcel of land which is known as part of Charlemont and Sterling Castle in the parish of St. Catherine and registered at Volume 1494 Folio 70, commencing at a point on the northern side of the parochial road leading from Charlemont to Linstead and proceeding in a north-easterly direction along a chain-

link fence for a distance of 59.21m and bordered to the north-west by a drain reserve, thence in a south-easterly direction along a chain-link fence for a distance of 91.44m and bordered to the north-east by the said drain reserve, thence continuing in a south-easterly direction along a chain-link fence for a distance of 123.89m and bordered to the north-east by the said drain reserve, thence in a more south-easterly direction along a chain-link fence for 41.21m and bordered to the north-east land registered at Volume 1494 Folio 71 to a point on the northern side of a reserved road leading from the aforementioned Charlemont to Linstead Parochial Road to the Charlemont Mud Stacks, thence in a south-westerly direction along a chain-link fence for a distance of 10.86m and bordered to the south-east by the said reserved road, thence continuing in a south-westerly direction along a chain-link fence for a distance of 45.01m and bordered to the south-east by the said reserved road, thence continuing in a south-westerly direction along a chain-link fence for a distance of 9.65m and bordered to the south-east by the said reserved road to a point on the aforementioned Charlemont to Linstead Parochial Road, thence in a north-westerly direction along a chainlink fence for a distance of 49.63m and bordered to the south-west by the said parochial road, thence continuing in a north-westerly direction along a chain-link fence for a distance of 37.33m and bordered to the south-west by the said parochial road, thence continuing in a north-westerly direction along a chain-link fence for a distance of 96.17m and bordered to the south-west by the said parochial road to the point of commencement, or however or otherwise the same land may be butted and bounded by or described, and containing by survey 14,775.08m².

- 3. The Special Economic Zone may be referred to as Lanco Industries Limited and is to be designated a Single Entity Zone.
- 4. The Special Economic Zone Authority to enter into a Licence Agreement with Lanco Industries Limited.
