**THE SPECIAL ECONOMIC ZONES ACT**

THE SPECIAL ECONOMIC ZONE (SUV WORLD LIMITED—PART OF RICHMOND PARK,  
KNOWN AS PART OF 66 HALF WAY TREE ROAD, KINGSTON 10) ORDER, 2019

In exercise of the powers conferred upon the Minister by section 18(1) (Designation of Special Economic Zone), section 22 (Minister's approval required), section 27 (Duration of master-concession and licence agreement) and section 53 (Tax incentives applicable to former Free Zones) of the Special Economic Zones Act, 2016, the following Order is hereby made:—

1. This Order may be cited as the Special Economic Zone (SUV World Limited—Part of Richmond Park, known as Part of 66 Half Way Tree Road, Kingston 10) Order, 2019.
2. Part of Richmond Park known as Part of 66 Half Way Tree Road registered at Volume 1465 Folio 573 Starting at a point that is 23.8 metres north-east of the south-east boundary, thence, north  $36^{\circ} 10' 51''$  West for a distance of 41.24 metres to a point on a line, thence, North  $44^{\circ} 58' 45''$  East for a distance of 5.12 metres to a point on a line, thence, North  $45^{\circ} 35' 27''$  west for distance of 11.85 metres to a point on a line, thence, South  $44^{\circ} 43' 10''$  west

for a distance of 6.89 meters to a point on a line, thence, North 45° 58'00" West for a distance of 9.48 meters to a point on a line, thence, North 44° 02'00" East for a distance of 7.28 meters to a point on a line, thence, North 45° 58'00" West for a distance of 0.93 meters to a point on a line, thence, North 44° 48'38" East for a distance of 24.50 meters to a point on a line, thence, North 45° 25'08" West for a distance of 2.65 meters to a point on a line, thence, North 45° 16'52" East for a distance of 23.01 meters to a point on a line, thence, South 32° 05'54" East for a distance of 32.28 meters to a point on a line, thence, South 39° 37'33" West for a distance of 5.34 meters to a point on a line, thence, South 58° 07'31" West for a distance of 10.02 meters to a point on a line, thence, South 31° 52'9" East for a distance of 7.56 meters to a point on a line, thence, North 58° 46'02" East for a distance of 3.16 meters to a point on a line, thence, South 36° 32'16" East for a distance of 6.24 meters to a point on a line, thence, South 53° 27'44" West for a distance of 4.77 meters to a point on a line, thence, South 36° 32'16" East for a distance of 8.87 meters to a point on a line, thence, South 61° 43'39" West for a distance of 1.67 meters to a point on a line, thence, South 27° 47'22" East for a distance of 18.75 meters to a point on a line, thence, South 62° 04'16" West for a distance of 1.20 meters to a point on a line, thence, South 26° 34'00" East for a distance of 1.90 meters to a point on a line thence South 58° 12'10" West a distance of 22.86 meters to the point of beginning.

3. The Special Economic Zone to be a Single Entity Developer and may be referred to as SUV World Limited.

4. The Special Economic Zone Authority to enter into a Licence Agreement with SUV World Limited.
